With due respect and humble submission I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint against the absconded accused person namely Sanjit Mondal s/o Late Kalachand Mondal of Mahamaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri after producing the following seized articles under proper seizure list.

i. Eight (08) sealed Bottles of "GALAXY BOSS 60 U.P INDIA MADE LIQUOR each bottle containing 600ml [Total 08 X 600 ml = 4.800 Litres] each Bottle containing 600 ml.

ii. Thirty Eight (38) sealed Bottles of 70 U.P OYE OYE GALAXY INDIA MADE LIQUOR each bottle containing 300ml. [Total 38 X 300ml =11.400 Litres]

to the effect that today on 20.01.2025 at about 20.25 hours I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 688, Date: 20.01.2025 received a source information that one Sanjit Mondal of Mahamaya Colony is selling illicit liquor in his tea shop at Ambari Bazaar under Bhorer Alo PS. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force of Bhorer Alo PS left for Ambari Bazaar to verify the said information in hand.

At about 20.35 hours I along with force reached at Ambari Bazar and being shown and identified by the source I along with force held raid at the shop of said Sanjit Mondal but after seeing the Police team the said Sanjit Mandal managed to flee away from the shop. Further in presence of available witnesses I, along with my accompanied team searched his shop and found/recovered the huge amount of above noted seized liquor from his

During enquiry the owner of the shop is identified as Sanjit Mondal s/o Late Kalachand Mondal of Mahamaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri and on further enquiry it could be learnt that he has been involved in selling and possessing of illicit liquor in his shop without any valid license since few months for his illegal gain. The absconded accused person Sanjit Mondal has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 20.01.2025 in between 20.40 hours to 20.59 hours.

Under the above noted fact and circumstances I, pray before your good self that a specific case under proper section of law may kindly be initiated against absconded accused person namely Sanjit Mondal s/o Late Kalachand Mondal of Mahamaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
