Sub – Lodging of FIR against Smt. Parvati Mishra for Threats, Abuse and Harassment

Respected Sir/Madam,

I Sri Rabindra Prasad Thakur, Son of Late Bindeshwari Thakur, Retired Person by occupation, resident of Tadong MW, NH 31 A Near Entel Motor, 6<sup>th</sup> Mile, P.S. Sadar, District East Sikkim, Gangtok, PIN – 737102, would like to formally lodge a complaint regarding continuous harassment, threat and abuse by Smt. Parbati Mishra.

The incidents have been occurring since 14th February 2025, at my property located at Amtala Road, Chayan Para, Roy Colony More. The accused, Smt. Parvati Mishra, has been unlawfully entering my land, using abusive and obscene language, threatening me, and attempting to force me to vacate my legally owned property. She has also been sending multiple individuals to intimidate and threaten me. These actions are causing harm to my reputation, financial loss, and severe mental distress. I am also facing a serious threat to my life due to these repeated acts of harassment.

Additionally, she is falsely claiming ownership of my property, further escalating the dispute. Local residents have witnessed these incidents, and I fear for my safety and well-being.

Here to be mentioned that the Ld. Civil Judge, Junior Division Court at Jalpaiguri on 14.02.2025, in C/W Title Suit No.128 / 2025, has been pleased to pass an **Ad-interim injunction order** that the Defendant, namely 1. Rathin roy, and, 2. Smt. Parbati Mishra, are restrained from interfering with the peaceful possession of the plaintiff (Rabindra Prasad Thakur) over the Suit property (as mentioned above) till next Date fixed on 14.05.2025
