## Respected Sir/Madam,

I, Ms Natalia Ghosh, daughter of Sri Bikash Ghosh, residing at 2nd Satyen Bose Road, Shivmandir, Post Office Kadamtala, Police Station Matigara, PIN code 734011, hereby wish to lodge an FIR regarding a serious road incident involving my mother, Smt. Nandita Ghosh, aged 60 years, wife of Sri Bikash Ghosh, on 17/02/2025.

On 17/02/2025 at about 3.10 pm, my mother was returning home walking from the SBI NBU branch. She was walking along the extreme left corner of the road when a Toto, driven recklessly at an exceedingly high speed, hit her from behind. The impact was severe, causing her to fall face-first onto the ground. Upon inquiring with nearby witnesses, I was informed that the Toto driver was driving carelessly and negligently, endangering the safety and lives of pedestrians. After hitting my mother, the driver fled the scene, leaving her in a severely injured state without providing any assistance. The Toto was blue in colour.

As a result of the incident, my mother sustained grievous injuries, including a fractured joint in her right arm and severe swelling around her right eyebrow, which has rendered her right eye red and closed. The injuries resulted in significant blood loss, further worsening her condition. That injuries are fatal and has endangered her life.

It is pertinent to mention that my mother already suffers from chronic health conditions, including high blood pressure and severe diabetes, which make her highly susceptible to complications. Additionally, she has undergone previous medical procedures that have left her physically weakened. This incident has exacerbated her health issues, leaving her in a critical state.
