With due regards, I **SMT. PUJA DEVI**, Wife of Pramod Paswan, Resident of Majoor Colony, Desh Bandhu Para, Ward No. 28 of S.M.C, P.O & P.S- Siliguri Dist- Darjeeling would like to lodge this written complaint to the effect that – I am married to Sri Pramod Paswan and our marriage was solemnized on 09.05.2023 according to Hindu Rites and Customs on and from Begusarai, Bihar and since our marriage, I am residing with my Husband, my Sister-In-Law and my old aged Father-In-Law at my above-mentioned matrimonial house.

Madam, Since the inception of my marriage, my Brother-in-Law namely Sri Amarjeet Paswan, along with his wife, Smt. Tuna Devi and their daughters namely Smt. Dipa Devi and Smt. Neha Kumari, along with their other relatives have repeatedly abused me with filthy and offensive languages and they have always taunted me without any reason and moreover, they on regular occasion have demanded a large sum of money from me to bring from my parental house as Dowry and when I refused to their unlawful and unjust demands, saying that I come from a financially weak family, they used to threaten me with dire consequences.

Madam, though my husband never mistreated me since our marriage but however, my Brother-in-Law namely Sri Amarjeet Paswan, along with his wife, Smt. Tuna Devi and their daughters namely Smt. Dipa Devi and Smt. Neha Kumari, along with their other relatives, have always shown their hatred towards me and continuously tortured me for repeated demand of Dowry and over the due course of time, they even began to threatened to kill me in absence of my husband by saying **"Jis din akela ghar me milega, tujhe maar dalunga"** and not only that, on many occasions, the said Amarjeet Paswan, along with his wife, Smt. Tuna Devi in presence of their daughters used to

physically assault me and moreover, the said Amarjeet Paswan has also touched me inappropriately but despite this I kept mum, considering the social prestige of my family and I also finding no other alternative, informed my husband and I always hoped that in the near future, they would definitely realize their own mistakes and rectify themselves and change their behavior towards me but, however, my all hopes were in vain as they continued to subject me to physically and mentally torture, especially when my husband was not around and since they live in our same house, under the same roof in different rooms, I constantly live in fear as they always looked for ways to harm me and end my life and unfortunately, in the month of November, 2024 during the auspicious occasion of Chhath Puja, when I was pregnant, the said Amarjeet Paswan, along with his wife, Smt. Tuna Devi and rest of his family members attacked upon me despite knowing fully well about my pregnancy, and they continued to assault me, causing severe complications in my pregnancy and as a result, I was unable to give birth to my child which left me deeply traumatized.

Madam, On 17.02.2025, while my husband was out of his house as he went to the market and my Father-In-Law being an old aged person stayed at his own room the said Amarjeet Paswan, along with his wife, Smt. Tuna Devi and their daughters namely Smt. Dipa Devi and Smt. Neha Kumari, along with the Mother-In-Law and the Sister-In-Law of Dipa Devi, along with other conspirators forcefully entered into my room in a pre-planned manner, and when I started to shout the said Amarjeet Paswan, and his wife, Smt. Tuna Devi held me down and assaulted me and their daughters also assaulted me with fist and blows and during such assault the said Amarjeet paswan touched me in a bad manner and molested me and not only that, they also tried to strangle me with a Dupatta, saying that they would not let me give birth to a child so that their property would not get divided and the said Amarjeet Paswan also carried a knife with him with which he started to threaten me of killing me and end my life permanently and somehow I managed to escape and rescue myself from their hands and then informed the entire incident to husband since his return and then, my husband took me to Siliguri District Hospital for treatment and due to their brutal assault, I also suffered bodily injures especially on my lower abdomen, head and neck,

as they attempted to strangulate me and kill me and in this way they have made my matrimonial house an unsafe living environment for me.

I, therefore, request you to investigate into the matter and please take strong legal steps against the **said Amarjeet Paswan, Son of Sri Upinder Paswan , Smt. Tuna Devi, Wife of Sri Amarjeet Paswan and their daughters namely Smt. Dipa Devi and Smt. Neha Kumari, Mother-In-Law and the Sister-In-Law of Dipa Devi, along with other conspirators** who entered into my room forcefully and assaulted, molested and tried to kill me in absence of my husband and treat my Written Complaint as F.I.R and oblidge thereby.
