I,Dilip Kumar Seth Son of Late Shyamlal Seth residing at Maharaja Colony, Word Mo. 4 od SMC, P.O-Siliguri Bazar, P.S-Siliguri, Dist.-Darjeeling do hereby lodged this written complain stating that I have a land measuring about 2 katha 10 chattak 30 sq ft comprised in R.S.Khatain No. 291/13 appertaining to R.S.Plot no. 7/122 corresponding to LR Plot no. 400, Sheet no. 4(LR), R.S. Sheet No. 5, Mouza-Dabgram, JI No. 02, Police station-Bhaktinagar, District-Jalpaiguri, which has been described in the Schedule bellow with specific boundary. That I have purchased the land by way of registered Deed of Sale vide Sale Deed no. I-521 dated 18.06.2013 from one Ashim Basnet son of B.S.Basnet of Bishal Gaon, Gangtok, Sikim and acquired possession accordingly and possessing the same without any disturbance from any corner.

That in the last year one Binod Kumar Agarwal Son of Late Khajanchi Ram Agarwal of Singtam Nagar Panchayet, Daragaon, Singtam Forest Block, P.O & P.S-Singtam, District-East Sikim along with one Ganesh Karjee son of Lt. Gurupada Karjee of Chayan Para, Roy Colony, near Roy Company house, word no. 42 of SMC, P.O-Shalugara, P.S-Bhaktinagar, District-Jalpaiguri continuously trying to disturbance my possession and subsequently they have procured several forged deed in connivance with one Kanchan Gurung wife of Man Bahadur Gurung residing at Upper Mangmoo, near Dentam Senior Sec School, P.O-Dentam, P.S-Uttarey, Dist.-West Sikim and one Bishal Agarwal Son of Sushil Kumar Agarwal residing at 20A, Hee sopong, Gagzing, West Sikim and also in connivance with one surveyor viz. M. Acharya, Regd no. 3895/75 who prepared one forged side plan attached with the forged deed vide deed no. 071105085 dated 19.07.2023 with an intention to grab my land.

That Kanchan Gurung had purchased one land measuring about 15 katha by way of registered Deed vide Deed No. I-5976 dated 26.12.1991 and in the said deed it has very much clear in the annexed map showing in the North there is 20 ft wide Road but at the time of preparation of the deed no. 071105085 dated 19.07.2023 said Binod Kumar Agarwal in connivance with Kanchan Gurung, Bishal Agarwal and surveyor viz. M. Acharya ,Regd no. 3895/75 of the map of the said deed in fraudulent manner prepare the forged description of the land by showing in the north there is 100ft wide Road with an intention to grab my land for their personal gain and also with an intention to cheat me amounting to more than Rs. 2.15 crore for their personal gain. That in this situation as and when I have challenged the said deed said Binod Kumaragarwal and his associate Ganesh Karjee continuously threatened me.

That in this circumstances I pray before your goodself to enquire the matter and to take appropriate legal steps against the above noted persons and obliged thereby.
