I, Debaditya Paul son of late Gopal Paul residing at Khalpara, Opposite to Paramount Hospital P.S. Siliguri Dist. Darjeeling do hereby lodge a complaint against Sri Sourav Mitra son of Sri Bhuju Mitra and Sri Bhuju Mitra son of not known, residing at Ramghat, Jalpai more, Siliguri, Dist. Darjeeling to the effect that on 19.2.2025 at about 4-430 P.M. I had gone to the house of Bhuju Mitra who carries decorator business placed order for pandel to my house for shradh ceremony of my grandmother. When I placed the order for pandel at my house then Bhuju Mitra told regarding outstanding dues of Rs. 3,000.00 from me claiming previous occasion against pandel, though no dues outstanding against me, over this issue Bhuju Mitra used abusive turned to scuffling then he called his son Sourav Mitra and intolerable languages used towards me and all on a sudden Sourav Mitra did strike on head armed with iron rod causing bleeding injury and bodily pain. Thereafter I called my mother and family members and they arrived at the spot while they tried to rescue me then sourav & Bhuju Mitra hit by fist and blows to my mother she got also sustained injury then I rushed to Siliguri Hospital and after treatment they release me, but at about 9-9-30 I felt unwell due to causing injury then I admitted to paramount hospital for better treatment. They also armed with dangerous weapon causing grievous hurt and threatened me with dire consequences. I further complain that at the time of scuffling my gold chain was dropped however I could not trace out, I reason to believe that the said gold chain may taken away with an intention to use for their personal use. I and my family members was engaged for my treatment as such

I would therefore request you to take action against Bhuju Mitra and Sri Sourav Mitra under the Bharatiya Nyaya Sanhita for causing grievous hurt and misappropriation of my lost Thanking you
