With due respect I, Smt. Papiya Saha, Wife of Sri Shantanu Saha & Daughter of Sri Gouranga Saha, presently residing at Sukanta Nagar, Near Alok Sangha Club, P.S-Bhaktinagar, Dist- Jalpaiguri, would like to inform you that my parents were looking a suitable groom for me through a matrimonial website. On the matrimonial website, they came to know one Sri Shantanu Saha, Son of Sri Naba Kumar Saha, resident of Lebu Bagan, Surya Nagar, near Dr. Kunal Goswami, P.O. Alipurduar Court, Dist- Alipurduar and after connecting with his parents and other family members, finding the groom appropriate as per our requirements, on 19.06.2024 I was given marriage to him and our marriage was solemnized in accordance to Hindu Rites and Customs at my paternal home at Sukanta Nagar.

I would like to further inform you that prior to the said solemnization of marriage in accordance with Hindu culture, I alongwith my husband registered our marriage on 14.06.2024 before the marriage officer Sri Dipak Kumar Roy according to the Special Marriage Act, 1954 as per the desire of the family members of both the sides.

I would like to further inform you that, at the time of negotiation of the marriage, my father had transferred a sum of Rs. 1,50,000/- (One Lac Fifty Thousand) only through his bank account in favour of my husband and a sum of Rs. 5,00,000/- (Five Lacs) only by way of cash and also gave a one Wooden Khat, one Table, One Sofa Set, one Worddrobe, alongwith gold ornaments for myself and a Gold Finger Ring, One Charles Chain for my husband and other household electronics and kitchen appliances.

Under Bhaktinagar PS came to realize that my husband is suffering from some sexual disease and he is incapable of indulging in sexual activities. The next morning, when I asked my mother-in-law namely, Smt. Anita Saha that why she did not disclose me or my family regarding the disease of my son or his impotency, she got furious and called my husband and then they both started to thrash me and pulled me by my hairs and closed me inside a room without any light, food or water.

I would like to further inform you that when I went to my paternal home for astamangala ritual, my husband and my mother in law had threatened me that if I tell anything to my family members then they will make my life measurable by pouring acid on my face and I will not be able to show my face to anyone. Since, my father has

incurred huge expense for my marriage and also borrowed money from people for giving mymarriage, I kept silent and did not informed anything to my father or any other family member.

I would like to further inform you that in my matrimonial home, my mother -in-law, brother-in-law namely SubhamSaha and my husband made my life like a hell and they did not leave an opportunity to harass and torture me. It is pertinent to mention here that I was neither allowed to go out of the house nor I was permitted to meet with the relatives or neighbors. I was also not allowed to dry my cloths in balcony and open the window of my room therebyforcing me to stay in the dark.

I would like to further inform you that, my husband and his family members always used to abusive filthy languages upon my family members and also started to demanded a sum of Rs. 50,00,000/- for purchasing a new SUV car and also invest the rest amounts in mutual funds and on refusal my husband alongwith his mother and brother assault me brutally.

I would like to further inform you that on 15.02.2025, at night about 07:30 Pm, my mother in law, brother in law and husband came to my room and my husband dragged me with my hairs and threw me out of the house and when I tried to resist, he kicked on my stomach and back and I fell down thereafter, my mother in law spit on my face thereafter, my brother in law tried to pull my saree and tried to disrobe me and my husband and mother in law were encouraging the said act of my brother in law even my mother in law and husband also told me to sleep with my brother in law as he is more competent then my husband on bed, thereafter I informed to my father over mobile phone and spent whole night at my relatives house namely Sibnath Chakraborty (maternal uncle / mama) situated at Khagra, Alipurduar, and on the next day morning i.e. on 16.02.2025 my father reached at Alipurduar and recover me from there and thereafter I came to my paternal house with my father.

I would like to request you to investigate the matter and do necessary action against my husband and his mother and brother for the ends of justice.
