Subject: Complaint Regarding fraudulent withdrawal of ₹ 16,500 from SBI ATM  
near Don Bosco Home, Siliguri.

Reported SBI,

I, Kavish Agarwal, resident of Tyetinagar, would like to bring to your notice a case of financial fraud that occurred with my father, Vijay Kumar Agarwal on 15/02/2025 at around 9:00 am at the SBI ATM near Don Bosco home Siliguri.

My father had gone to withdraw money from the mentioned ATM, where he successfully withdrew ₹ 5000 using his ATM card. However, after this transaction, his card got stuck inside the machine and was not coming out. On the right side of the ATM wall, a helpline number was displayed, which my father called for assistance. The person on the call instructed him to press cancel button five times, but the card remained stuck. He then asked my father to enter his pin three times and press enter, yet the card did not eject.

The caller was contacted at 9546119637, assured my father that he would visit the ATM by 11:00 AM to retrieve the card and hand it over to the nearby shop that my father is familiar with. Trusting this information, my father left the ATM. However, later, while sitting at home, he received a message stating that ₹ 16,500 had been withdrawn from his account. Upon returning to the ATM, we found that the card was missing, and the money had already been fraudulently withdrawn.

ng this, we attempted to contact the same number multiple times, but the person has not been receiving any calls. Soon after the withdrawal, this number has become completely unreachable, and it appears that he deliberately disabled his network. Based on these suspicious activities, we strongly suspect that the person behind this number is responsible for the fraud.

Following this, we immediately contacted a police van from Bhaktinagar Police station, upon their arrival, the officer advised us to approach the SBI branch and request CCTV footage. However at SBI branch, we were informed that the CCTV footage could only be provided upon an official request from the cyber crime police station.

Therefore, I kindly request you to take immediate action in investigating this fraudulent activity, request the CCTV footage from the SBI Branch, and take necessary steps to trace the person responsible. I am attaching copies of relevant documents, including my father's bank transaction details, for your reference.

I sincerely hope that appropriate action will be taken at the earliest. Kindly acknowledge the receipt of this complaint and let us know about the next steps.
