Then he told me that my credit card limit is lower & If I follow his instruction he will make the credit card limit is higher, so he send a link to my whatsapp number. When I clicked the link another website was open . Then he made whatsapp video call to me . I accepted the Whatsapp Video Call. Then he instructed me & as per his instruction I entered my first credit number 5256 1188 3617 1637 of Bajaj Finserv connected with RBL Bank , my date of birth 26.01.1972 & also share my another credit card number 5287349884513155 of State Bank of India , my credit card CVV number. After that My SBI Credit Card App was disabled. I got messages that Rs. 2,251.92 deducted from RBL Bajaj Finserv Credit Card on dated 15.02.2025 at about 2.46 pm. Then I went to Mangaldeep Branch of SBI and generate the statement of SBI Credit Card where I found there were 5 transactions was made in SBI Credit Card. & debited Rs.58,798.00 from my SBI Credit card account , which was not made by me:

I am unable to provide RBL Credit Card Statement *Y am not getting the RBL statement because they are not providing.

In this way I had been victimized of fraudulent activity of my Credit Card.

So I therefore request you to lodge FIR and take necessary action to refund my amount.
