Sir,

In producing herewith two accused persons namely (1) Priyajit Roy (24 years) S/O Sri Dinesh Roy of Purbadhar PO Bhangamali PS Maynaguri Dist. Jalpaiguri and (2) Amal Sarkar (27 years), S/O Sri Sahadev Sarkar of Dharikamari PO Saptibari PS Maynaguri Dist. Jalpaiguri under custody and the following properties weighing total 23.700 Kgs under seizure ----

- (a) 02 (Two) packets said to be Ganja wrapped with brown coloured Cello tap weight 7(Seven)Kgs 400Grams & 4(Four) Kgs respectively which was kept in a one white & Red coloured plastic hand bag marked as exhibit-"A" recovered from the possession of above noted accused person as noted in SL no-(1).

  (b) Net 50 (Fifty) grams of Ganja drew up as sample from exhibit "A" marked as exhibit "A 1".
- (c) 02 (Two) packets said to be Ganja wrapped with brown coloured Cello tap weight 7(seven Kgs200 Grams & 5(Five) Kgs 100 grams respectively which were kept in a white coloured plastic hand bag marked as exhibit-"B" recovered from the possession of above noted accused person as noted in Sl no(2).

(d)Net 50 (Fifty) grams of Ganja drew up as sample from exhibit B'marked as exhibit B- 1".

I, S. I. Biswajit Biswas of Ashighar OP P.S.Bhaktinager SPC, do here by lodge this complaint to the effect that on 13.02.2021 at 15:30 hrs. received a secret source information that two notorious drug peddlers of maynaguri namely (1) Priyajit Roy and (2) Amal Sarkar are now standing at Kankata More, Ashighar with two bags of Ganja in their possession in order for its clandestine disposal at Kankata More area and they will be could be caught red handed, if they apprehended immediately. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No. 289 dated -13.02.2021 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with ASI Biswajit Ghosh , ASI Dipankar Banerjee and C/376 Shymal Choudhury and CV/616 Ananda Das all are of Ashighar OP left for Kankata More, at 15,35 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No. - 290 Dated-13.02.2021. On way to Kankata More, I called two independent witnesses namely [1] Dipankar Saha (31) S/O Shankar Saha of Ghugumali Niranjan Nager PS Bhaktinager Dist. Jalpaiguri and [2] Sujit Roy (28) S/O Sanjay Roy of Naresh More PO Ghugumali PS Bhaktinager Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 15.45 hrs. myself along with my accompanying party arrived at Kankata More and at contacted with my source. At 17.55 hrs. as identified by my source myself along with my accompanying party surrounded the above noted accused persons having two plastic hand bags in their possession which they had kept in their middle while standing and waiting for someone . On being asked they disclosed their identify as noted above . On being further asked they stated that the content inside the plastic hand bags in their possession is Ganja . After disclosing our identity I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and

They agreed to be searched in presence of any Gazetted Officer. I served them a notice in Inspector Incharge Siliguri Police Station , SPC and requested him to remain present at the spot as Gazetted Officer. At 16.25 hrs. Shri Sudip Chakraborty , Inspector Incharge Siliguri Police Station , SPC arrived at the spot . I disclosed the identity of Shri Sudip Chakraborty, Inspector Incharge Siliguri Police Station, SPC to the accused persons as Gazetted Officer. Under supervision of Shri Sudip Chakraborty, Inspector Incharge Siliguri Police Station , SPC and the above noted witnesses the aforesaid accused persons and the above noted plastic hand bags were searched keeping strict regard of their decency and recovered Ganja contained inside the four numbers of packets wrapped with brown coloured cello tap, which the above noted accused persons were carrying themselves. They further confessed in presence of Gazetted Officer and other witnesses that they procured the Ganja from Assam clandestinely for the purpose of its selling with a view to earn huge money quickly. On interrogation they disclosed that they had been dealing in such business for last few years importing it from Assam and selling the same at Ashighar and its adjacent areas. On being asked they failed to produce any documents or license in support of their possession of Ganja. Then as per direction of Shri Sudip Chakraborty, Inspector Incharge Siliguri Police Station, SPC I weighed the Ganja with weighing instrument and found that weight of 02 (Two) packets wrapped with brown coloured Cello tap 7(Seven)Kgs 400Grams & 4(Four) Kgs respectively which were kept in a white & Red colour hand bag marked as exhibit - " A " from which 50 (Fifty) Gms of Ganja was drew up as sample which was marked as exhibit - "A-1" and weight of 02 (Two) packets wrapped with brown coloured Cello tap 7(Seven) Kgs 200 Grams & 5(Five) Kgs 100 grams respectively which were kept in a white coloured plastic hand bag marked as exhibit - "B" from which 50 (Fifty) Gms of Ganja was drew up as sample which was marked as exhibit - "B-"1" Then , I packed , labeled and sealed two bags and sample in presence of witnesses, and seized all the above noted recovered articles as Alamat under proper seizure list under the supervision Shri Sudip Chakraborty, Inspector Incharge Siliguri Police Station, SPC duly signed by the local witnesses and the accused persons . The seizure was made in between 16.55 hrs and 17.25 hrs. Then , I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused persons and witnesses . The copy of seizure list and memo of arrest have been supplied to the above noted accused persons under receipt. Thus, the accused persons violated the terms and conditions

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Priyajit Roy (24 years) S/O Sri Dinesh Roy of Purbadhar PO Bhangamali PS Maynaguri Dist. Jalpaiguri and (2) Amal Sarkar (27 years), S/O Sri Sahadev Sarkar of Dharikamari PO Saptibari PS Maynaguri Dist. Jalpaiguri and arrange for its investigation .
