Respected Sir,

In producing herewith two accused persons namely 1) Dipak Paswan @ Motra (28) S/O Fuden Paswan of Unnyan Colony, Fuleswari, Ward No.24, PS- Siliguri Dist- Darjeeling and 2) Biki Paswan (24) S/O ~~S/O~~ Fuden Paswan of Unnyan Colony, Fuleswari, Ward No.24, PS- Siliguri Dist- Darjeeling along with seized articles viz- 1) 30 (thirty) bottles of "Codeine Phoshate & Chlorpheniramine Maleate Cough Syrup" styled as ESKuf containing 100 ml each having batch no. JESL-412, Mfg date-11/2019, exp date- 10/2021, 2) One white color Honda DIO Scooty bearing no. WB74/AL-3168 and 3) one black color plastic bag to the effect that today i.e 15.02.21 at 07.45 hrs I received a secret information that two persons were coming towards Jalpaimore from Noukatmore with huge quantity cough syrup illegally to dispose off the same at Jalpaimore area under PS Siliguri. I diarised the matter Vide Siliguri PS GDE No. 890 dated 15.02.21 and informed to I/C Siliguri PS. Myself along with ASI Subir Sen, Const-917 Sanajy Roy, CV-145 Bijay Das and CV-622 Ramanath Barman left for Jalpaimore to verify the veracity of information. At about 07.55 hrs we reached at Jalpaimore under PS- Siliguri, Dist- Darjeeling. Then we started a Naka Checking there. As per identified by source we managed to stop one above noted mentioned scooty and detained them there by the help of local people.

In presence of the witnesses I found that one person namely Biki Paswan was riding the said scooty and one person namely Dipak Paswan @ Motra was carrying a black color plastic bag containing 30 (thirty) Cough Syrup and after searching 25 (twenty five) bottles of "Codeine Phoshate & Chlorpheniramine Maleate Cough Syrup" styled as ESKuf containing 100 ml each. I interrogated the above noted persons who disclosed their identity as noted above. On demand they could not produce any document in support to carry the above noted Cough Syrup and confessed that they procures the same illegally with intension to sale to young people at Jalpaimore area under Siliguri PS for their wrongful gain. So I Seized and labeled, viz- 1) 30 (thirty) bottles of "Codeine Phoshate & Chlorpheniramine Maleate Cough Syrup" styled as ESKuf containing 100 ml each having batch no. JESL-412, Mfg date-11/2019, exp date- 10/2021, 2) One white color Honda DIO Scooty bearing no. WB74/AL-3168 and 3) one black color plastic bag under proper seizure list in presence and duly signed by the witnesses and arrested the above noted accused person u/s 41 Cr.PC after issuing Memo of arrest. The seizure and lable was made in between 08.25 hrs to 09.15 hrs.

I, therefore, pray to your kind honour that a specific case may kindly be started against accused person namely 1) Dipak Paswan @ Motra (28) S/O Fuden Paswan of Unnyan Colony, Fuleswari, Ward No.24, PS- Siliguri Dist- Darjeeling and 2) Biki Paswan (24) S/O S/O Fuden Paswan of Unnyan Colony, Fuleswari, Ward No.24, PS- Siliguri Dist- Darjeeling under proper section of law.
