Respected Sir,

1. Shri Rakesh Agarwal, son of Late Hanuman Das Agarwal, resident of Bhagwati Apartment, Punjabi para, P.S.-
Siliguri, Dist: Darjeeling, do hereby lodged this complaint against 1. Aloka Roy wife of Gobinda Mohanta of
Chakiavita, Ambari, Dist: Jalpaiguri. 2. Smt. Chopala Roy (Mohanta) wife of Late Dipen Roy of Chakiavita,
Kamarvita, Ambari, Dist: Jalpaiguri and more 6/7 persons unknown of that locality conjointly on 11-02-2021 at
about 12 pm. came to our work site at Ambari, Chakiavita under Ambari out post and started taking away by
force showing deadly weapons to the Night Guard of our site all stored/staked iron rod weighing one ton
approximately, valued Rs. 60,000.00 approximately by loading in some Thela Rickshaw and threaten our workers
and managers by putting fear of death and told that if anybody of our site informed this matter to the police
station in that case the offenders will not hesitate to kill our workers and managers of the site and for this illegal
activities, the workers of the site are in tremendous fear in view of their dangerous and desperate nature. It is
relevant to mention here that on 07-02-2021 one GDE was filed in the Ambari police station regarding theft of
iron rod by damaging boundary wall of the site using their muscle power illegally and the said matter was
informed to the O/C Ambari vide GDE No. 218 dt. 07-02-2021 but no result yielded till today and no recovery was
made.

Under the circumstances, your goodself would be kind enough to investigate into the matter and save our life by
way of using your heavy hands in the interest of justice or do the needful as your goodself thinks fit and proper.
