With due respect, I, Sri Rajesh Kumar Yadav, S/o Sri Banarasi Yadav, resident of Gnga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling would like to inform you that I am the registered owner in possession of all that piece or parcel of land measuring about 3 Kathas 4 Chhataks recorded in Khatian No - 167, having Plot No - 2120 (part), J.L No - 110 (88), under Mouza - Siliguri, Paragana - Baikunthpur, P.S - Siliguri, District - Darjeeling and since the date of purchase of the aforesaid landed property I am possessing and enjoying the same free from all encumbrances and charges what-so-ever. Yesterday i.e. 15 - 2 - 2021 at about 11.30 p.m. I came to know that some antisocial elements of the locality have organized Sarasawti Puja in my land without any knowledge and consent and today i.e. 16 - 2 - 2021 at about 9.30 a.m I had been to my landed property, and found that one Binod Paswan, Sri Pramod Paswan, both are sons of Sri Parmeswar Paswan, Abhishek Paswan, S/o Binor Paswan and Parmeswar Paswan all are resident of Maharaj Colony, P.O. - Siliguri Bazar, P.S.- Siliguri, District - Darjeeling, Santoshi nagar, P.O. - Siliguri Bazar, P.S.- Siliguri, District - Darjeeling, Sri Jitendra Prasad, S/o Biswanath Prasad resident of Ganganagar, Ward No - 5, P.O & P.S - Siliguri, Sri Mayanath Gour @ Final, S/o Raja Ram Gour of Khalai Bhaktri, P.S - Matigara, District - Darjeeling, Md. Azad S/o Md. Shehzad of Basu Colony Ward No - 4, P.O & P.S - Siliguri, District - Darjeeling, Sri Sumit Mishra, S/o Not Known, resident of Chanapatty, ward No - 6, Siliguri, Darjeeling, Sri Bimal Biswas, S/o Not known, resident of Santoshi Nagar, ward No - 5, P.O & P.S - Siliguri, District - Darjeeling and 4-5 persons are trying to construct Sarswati Puja Pandal in my land to disturb me illegally with intention to occupy my landed property and after seeing me the above named persons became furious and have abused me in filthy languages and threatened with dire consequences to return back, finding no other alternative, I returned back to my house. It is to be mention here that on previous occasions the above named persons have also tried to occupy my landed property but due to your interference, I can able to protect my landed property. But their day to day illegal activity creates, lot of doubt that the above named persons are adamant to occupy my land by this and that though they are well acquainted with the facts that there is a Civil Suit against them and the Ld. Court was pleased to pass injunction order against the above named persons in the manner as follows ; ".....that the ad interim prayer of the plaintiff be and the same is allowed to the extent of restraining the defendants from disturbing peaceful possession of the suit property by the plaintiff till 08.01.2020 " and the said Injunction order is extended till 20 - 3 - 2021 against the above named persons.

Be, it mention here that inspite of having the information of order of injunction, the above named persons, still trying to erect Saraswati Puja Pandal in my land by trespassing in the same.

The above named persons have no regard in law and order and they are the man of desperate in nature.

So, you are hereby requested to investigate the matter and take necessary legal actions against the above named persons and remove the Puja Pandal from land for that I will highly oblige to you.
