With due respect, I, Sri Rajesh Kumar Yadav, S/o Sri Banarasi Yadav, resident of Gnga Nagar, Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling would like to inform you that I am the registered owner in possession of all that piece or parcel of land measuring about 3 Kathas 4 Chhataks recorded in Khatian No - 167, having Plot No - 2120 (part), J.L No - 110 (88), under Mouza - Siliguri, Paragana - Baikunthpur, P.S - Siliguri, District - Darjeeling and since the date of purchase of the aforesaid landed property I am possessing and enjoying the same free from all encumbrances and charges what-so-ever.
