I, Smt. Lalita Devi Gupta, wife of Lt. Harihar Prasad Gupta, daughter of Late Jagmohan Lohar (a schedule tribe), resident of Hospital More, P.O. and P.S.:- Bagdogra, Dist. Darjeeling, W.B. do state the matters in the following:-

- 1) That, one Narayan Sha, father's name not known, resident of Upper Bagdogra, Hospital More, Sukanta Nagar, P.O. and P.S.:- Bagdogra:-Dist. Darjeeling W.B. on 11.02.2021 at about 01.00 p.m. caught hold of my hand pulled me while I tried to let my myself loose, he caught my carry bag. He tried to outrage my modesty. At that time I was on the way to Kishangunj to my daughter's home for urgent need. In fact, Narayan Sha was forcing me to sit in a meeting called by him and his hired men with a motive to oust me from my house and land.
- 2) That since many years said Narayan Sha has been trying to dispossess me from my home and place measuring about 2.50 Kathas wherein I have been staying since more than 40 years and I have been paying tax and have electric connection in my name in my house premises at Hospital More. I am a voter of the locality and have other proof of my stay at Hospital More Bagdogra, Dist. Darjeeling.
- 3) That today 15/02/2021 at about 10.a.m. I found that said Narayan Sha demolished my tinned fence and have trespassed in my house premises and have been forcibly trying to raise structure.
- 4) That I belong to tribal community and my own parental relatives stay at Kamalpur T.E. Bagdogra.

I therefore request you to kindly start a strong case against Narayan Shan his sons and others and oblige.
