I Somnath Saha S/o Rabindranath Saha residence of Uttarayon MIG Tower No : 17 Flat No 001 Working as a Manager at Beer Republic , City Center , Matigara , District Darjeeling would like to inform you that on 19th February 2021 at around 12:30 AM After closing the Restaurant cum Bar while returning home I was Stopped by Goon at City Center, Matigara, Dist Darjeeling VIP & Officers Parking Area, They were around 15 to 20 Goons and there Leader namely Wajid Ali, Rahul Tamang and Subham Mahato residence of Siliguri, who were all waiting for us with sharp

I with my staff were leaving from work premises after closing towards our homes at around 12.30 am these guys were waiting for us with sharp weapons at the city center exit gate. As we reached the exit point the all surrounded us and stopped us into an arugment and they all took out sharp weapons, Fire arms, Steel Rods, Knife and other kinds of deadly weapons. In no time they all started attacking with blows, knife, Knuckles. I am badly beaten by them and my nose borne is completely broken and with unbearable pain, struggling between Life and Death at Neotia Getwel Hospital at Fourth Floor Bed No 2505. A Guy Name Wajid Ali took out Sharp Knife and started shouting " Aaaj tera Murder Kardunga ". They were in a group of 15 to 20 guys and to kill us with their weapons. I am struggling between life and death at Neotia Getwel Hospital at Fourth Floor Bed No 2505 and during this incident he also lost the Gold Chain, Gold ring and cash around 12500/-.(Rupees .Twelve Thousand Five Hundred).

I want to request you to please look into this matter urgently as these people are still roaming outside and can ambush and attack at any point of time as they have promised to take my life.
