That I immediately called my mother and somehow I 11. reached my father's house and described the incident to them and am now lodging this complaint. Sir, I therefore request you to look into the matter and take necessary legal action against the said Sanjay Dey, for forcefully apprehending me, threatening and abusing me on the streets and also beating me publicly and punish him according to law for the ends of Justice.
