- (3) 10 (Ten) bottles of "MC DOWELL'S NO1 CELEBRATION MATURED XXX RUM" each bottle containing 180 ML, MRP Rs. 153/-.
- (4) 07 (Seven) bottles of "Old MONK MATURED XXX PREMIUM RUM" each bottle containing 180 ML, MRP Rs.153/-.
- (5) 07(Seven) bottles of "OFFICER'S CHOICE DELUXE WHISKY "each bottle containing 180 ML MRP Rs. 140/-.

I ASI Dipankar Banerjee of Ashighar OP lodged a written complaint against the accused person namely namely Anil Haldar (40) S/O Late Upendra Haldar of Netaji Para Netaji Road Near Dhakeshwary Mandir PO Ghugumali PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Netaji Para Near Dhakeshwary Mandir area as indicated by my source I held raid at the house of Anil Haldar at Netaji Para Near Dhakeshwary Mandir . But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.30 hrs and 19.55 hrs on 22.02.2021.
