Sir,

In producing here with one accused person namely Anil Halder (40) S/O Late Upendra Halder of Netaji Para Netaji Road, Near Dhakeshwary Mandir PO Ghugumali PS Bhaktinager Dist. Jalpaiguri and the following articles under seizure:

- (1) 35 (Thirty five) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 300ML MRP Rs.50/-
- (2) 45 (Forty five) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/-
- (3) 10 (Ten) bottles of "MC DOWELL'S NO1 CELEBRATION MATURED XXX RUM" each bottle containing 180 ML, MRP Rs. 153/-.
- (4) 07 (Seven) bottles of "Old MONK MATURED XXX PREMIUM RUM" each bottle containing 180 ML, MRP Rs.153/-.
- (5) 07 (Seven) bottles of "OFFICER'S CHOICE DELUXE WHISKY" each bottle containing 180 ML MRP Rs. 140/-.
- (6) 05 (Five) bottles of "MC DOWELL'S NO1 RESERVE WHISKY" each bottle containing 180ML, in which three bottles costing Rs.184 & two bottles costing Rs 174/-.(Total quantity 65.4 Ltr amounting Rs 10,731/-)

I ASI Dipankar Banerjee of Ashighar OP lodged a written complaint against the accused person namely Anil Halder (40) S/O Late Upendra Halder of Netaji Para Netaji Road Near Dhakeshwary Mandir PO Ghugumali PS Bhaktinager Dist. Jalpaiguri to the effect that, on 22.02.2021 evening as per order of O/C Ashighar OP I along with ASI Inzamamul Hoque, C/ 877 Munna Ahmed CV/1016 Amrit Roy, all are of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP in course of which I received information from my source that one Anil Halder stored a huge numbers of bottles liquor inside his house at Netaji Para Near Dhakeshwary Mandir Ghugumali, and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Netaji Para Near Dhakeshwary Mandir Ghugumali area to verify the veracity of information. On the way I called two local person namely (1) Shankar Mandal (40) S/O Late Sunil Mandal of Ashighar Colony PS Bhaktinager Dist Jalpaiguri and (2) Dilip Ghosh (37) S/O Late Kali Kanta Ghosh of Netaji Colony PO Ghugumali PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Netaji Para Near Dhakeshwary Mandir area as indicated by my source I held raid at the house of Anil Halder at Netaji Para Near Dhakeshwary Mandir. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alammath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 19.30 hrs and 19.55 hrs on 22.02.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons namely Anil Halder (40) S/O Late Upendra Halder of Netaji Para Netaji Road Near Dhakeshwary Mandir PO Ghugumali PS Bhaktinager Dist. Jalpaiguri and arrange for its investigation.
