I, SI Goutam Mallik of NJP PS, Siliguri Police Commissionerate beg to state that on 24.02.21 night myself along with VP/08 Laxman Roy, VP/13 Jamirul Islam and CV/306 Biswajit Roy CV/123 Ratul Bhattacharjee were performing Plane Cloth mobile duty vide NJP PS GDE No 1193 dated 24.02.21. During my duty l received a source information that a gang of miscreants come to Ambika Nagar by two vehicles with deadly weapons and assembled there and making preparation for committing dacoity at Ambika Nagar area. Accordingly, I informed the fact to on duty officer of NJP PS and also informed the fact to O/C, NJP PS as well as Asstt. Commissioner of Police, East Zone, Siliguri Police Commissionerate who instructed me to verify the veracity of the information. I also informed the fact to night RT Van officer PSI Ajay Pradhan and directed him to come to Ambika Nagar to accompany with us. After a few time PSI Ajoy Pradhan along with force came to Ambika Nagar. At about 01.25 hrs we arrived at Ambika Nagar and kept our vehicle there and being shown by the source we proceeded towards two vehicles which were parked there. Being indicated by the source from a considerable distance we found a gang of 12/14 persons assembled in a dark place at Ambika Nagar hiding them self behind the vehicle and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them. But seeing the police party one vehicle and 7/8 persons managed to fled away but we the police party apprehended the one Maruti Car with the driver and others four persons.

On interrogation the apprehended accused persons disclosed their identity as noted above and they admitted that they had assembled there to commit dacoity in that area. On search I found the above noted articles in their possession. Accordingly, I arrested them under proper memo of arrest and observing all the formalities of arrest and seized the above noted articles under proper seizure list and brought to NJP PS. The search seizure and arrest made in between 01.55 hrs and 02.35 hrs.

Under the above noted fact and circumstance, I therefore pray to you that a specific case may kindly be started against the accused persons namely (i) Majibar Rahaman (21 yrs) S/o Safikul Islam of Paschim Dhantala, Murder More, PS- NJP, Dist.- Jalpaiguri (ii) Abbas Md (49 yrs) S/O late Keyamuddin of Jorpakhri, PS- NJP, Dist.- Jalpaiguri (iii) Saruk Md (21 yrs) S/O Md Raizuddin of Paschim Dhantala, Murder More, PS- NJP, Dist.- Jalpaiguri (iv) Prabin Roy (24 yrs) S/O Gopal Roy of Paschim Dhantala, Fulbari, PS-NJP, Dist.- Jalpaiguri & Dulal Roy (34 yrs) S/O lt Anil Roy of Pakali Bazar, Rajar Hat, PS- Mainaguri, Dist.-Jalpaiguri and arrange for its investigation.
