In producing herewith one arrested accused person namely Prafulla Debnath (40/Male) S/O-Lt Chimtu Debnath of- Adarsha nagar, W/No-04 PS-Siliguri, Dist-Darjeeling along with seized articles (1) 11(Eleveen) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N-1.

I, ASI Partha Paul of Panitanki TOP under Siliguri PS herby lodge a written complaint against the above noted accused person to the effect that on 22.02.2021 at 21.10 hrs received secret source information that one person is carrying huge quantity of bottle country spirit through Bidhan road front of Ato stand towards Adarsha nagar, Siliguri. Accordingly informed to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 559 dated 22.02.2021 and thereafter as per his direction I along with, ASI Biswajit Ghosh , C/153 Santosh Mahato, CV/1009 Manoj Thakur, left from Panitanki TOP vide Panitanki TOP GDE No-560 Dt-22.02.2021 at 21.20 hrs to work out the information. On arrival at Bidhan road front of Ato stand, Siliguri at 21.30 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses namely (1) Ujjal Mandal S/O-Haridas Mandal, of-Police line Jalpaiguri, PS-Kotwali, Dist-Jalpaiguri, 2) Parwinder Singh S/O-lt Jogendar Singh, of-Bhagat singh Sarani, Panjabipara, PS-Siliguri, Dist-Darjeeling. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Adarsha nagar, Siliguri adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 11(Eleveen) Bottles of 60 UP Country Spirit styled as PET Galaxy BOSS of 600 ml each when packed, MRP Rs. 100/- each 2) 01 (One) Nylon Bag which used for carrying the seized articles SL. No- 1. under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made between 21.40 hrs to 21.50 hrs I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1100/-

Hence, under the above noted circumstances I am submitting this written complain against the above accused person namely Prafulla Debnath (40/Male) S/O-Lt Chimtu Debnath of Adarsha nagar, W/No-04 PS-Siliguri, Dist-Darjeeling for starting a specific case under prope section of Law and to arrange for its investigation.
