Darjeeling, would like to inform you that on Dt. 23.02.2021 at about 10.30 pm at night, one Rajesh Shah S/o Not Known of Santoshi Nagar, Near Vishnu Mandir, ward No.5 SMC, P.O. & P.S. Siliguri called my brother namely, Md. Azad S/o Lt. Md. Sajjad of Memanta Basu Colony, Ward No. 4 SMC, P.O. & P.S. Siliguri, Dist. Darjeeling, by mobile phone at Patti Mill, Near Marayani Gas Agency and when my said brother arrived at the said place of occurrence, the said 1. Rajesh Shah 2. Raju Bhar S/o Suresh Bhar 3. Lalbabu Bhar S/o Not Known & 4. Sri Pankaj Sharma S/o Not Known all 3 are resident of Goala Patty, Ward No. 4 SMC, P.S. Siliguri, restrained him and started abusing him in filthy languages and when my said brother objected, they suddenly attack him and injured my brother with sharp cutting weapon. The above noted four persons threatened my brother for dire consequences.

My said brother anyhow managed to escape from the said place after receiving severe injury on his person and any how shifted at North Bengal Medical College and hospital and now under treatment there.

So, please take neccary action against above named alleged persons.
