1. Sixteen (16) Bottle of Himalayan Gold Country Spirit (each bottle containing 600 ML) .

I, SI Sajal Roy of Bhaktinagar PS,SPC lodged a written complainant against the above noted person to the effect that today i.e. on 25.02.2021 hrs at 21.15 hrs received a source information that at Ektiashal Hat ,PS-Bhaktinagar,Jalpaiguri some persons have gathered huge amount of liquor illegally beside the pipeline for selling the same in the customer for their wrongful gain.
