Sir,

In producing herewith one accused person namely Biplab Ch.Das (52) S/O Lt Barun Ch Das of Yuba Collony, Ektiashal PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Sixteen (16) Bottle of Himalayan Gold Country Spirit (each bottle containing 600 ML) .

I, SI Sajal Roy of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 25.02.2021 hrs at 21.15 hrs received a source information that at Ektiashal Hat ,PS-Bhaktinagar, Jalpaiguri some persons have gathered huge amount of liquor illegally beside the pipeline for selling the same in the customer for their wrongful gain. This refers to Bhaktinagar PS GDE no- 1537 dated 25.02.21. I informed SI J.V Lepcha ,holding charge of I/C Bhaktinagar about the information . As per his kind instruction I along with, ASI Rabin Lama, C/ 762 Majibur Rahaman , C/374 Debraj Biswas and CVF/619 Dharmendra Roy as proceed to Ektiashal Hat to work out the information. At 21.45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at pipe line, Ektiashal Hat and recovered the above noted articles from the possession of above noted accused person namely Biplab Ch.Das (52) S/O Lt Barun Ch Das of Yuba Collony, Ektiashal PS- Bhaktinagar Dist- Jalpaiguri . On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Prabhat Prasad (21) S/O Sri Ram Prasad of Vivekananda Nagar W/no-42 PS -Bhaktinagar Dist-Jalpaiguri .I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 22.35 hrs to 22.55 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Biplab Ch.Das (52) S/O Lt Barun Ch Das of Yuba Collony, Ektiashal PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
