but this time it was not only limited to the victim girl only but also to the child, while she was subjected to hear that the audacity of going to the panchyat was one of the biggest mistakes of her (MOON DEBNATH'S) life.

- 11. That thereafter on 03.04.2020 they (the accused persons) threw out the daughter of the complainant from her matrimonial home with a demand of rupees 4,50,000/- (four lacs and fifty thousand rupees only) and the accused persons assaulted the daughter of the complainant as a result of which she got several physical injuries and got treated by Siliguri District Hospital on 04.04.2020 by Dr. Anirban Nandi. The copy The O.P.D. Patient Card dated 04.04.2020 issued by the Siliguri District Hospital is attached as Annexure 4.
- 12. That thereafter on 30.10.2020 the victim girl MOON DEBNATH (DHALI) again beaten by her husband and mother-in-law grievously and got serious whole bodily Injury, which is specifically mentioned in O.P.D. Patient card dated 31.10.2020 issued by Siliguri N.B.M. C. Hospital of which the copy is attached here as annexure 5.
- 13. That several times the complainant and his daughter went to Ashigarh police out post to lodge written complaint against the above mentioned accused persons along with the supportive medical documents but they refused to lodge / start a criminal motion against the accused persons. Copy of Complaint dated 04.04.2020 and 31.10.2020 has been attached here as exhibit 6 and 7.
- 14. That because of the inactivity of the police personnel the accused persons became more venerable and on 19.02.2021 the accused No. 1 (Sanjay Dhali) beaten MOON DEBNATH(DHALI) and demanded money from her. Whenever she refused Anamika Dhali i.e. the accused No. 3 and Sanjay Dhali, i.e. the accused No.1 and Sadananda Dhali, accused No. 2. Started giving her voluntary gravious hurt by using wooden lathi and accused No. 2, brought 'Bathi Dah' and assaulted her seriously. And threw her out of her said matrimonial home. On 19.02.2021 MOON DHALI, the victim girl, got medical treatment under Siliguri District Hospital. Copy of Vide O.P.D. Patient Card dated 19.02.2021 is here attached as annexure 8.
- 15. That 20/02/2021 the complainant and his daughter went to ashighar police out post and Bhaktinagar Police station to lodge written complaint against the above





- That after the social marriage the daughter of the complainant and the accused no. 1 started to live together as husband and wife at the above mentioned residential address of the accused persons.
- That after passing few months the accused no. 1 namely Sanjay Dhali started cruel behavior with the victim girl i.e. Moon Debnath (Dhali) and physically assaulted my daughter with fist and blows.

It is pertinent to mention here that the parents - in - laws i.e. the accused no. 2 & 3 instead of saving / rescuing her instigated the accused no. 1.

- 7. That since the victim girl namely MOON DEBNATH (DHALI) became pregnant she was subjected to mental and physical cruelty alling that the child is not the offspring of the accused husband along with her in- laws i.e. accused no. 2 & 3, the daughter of the complainant was forced to pass her days in starvation at the time of her pregnancy and ultimately the victim girl was let out from her matrimonial home.
- 8. That on 31/08/2018 daughter of the complainant i.e. the victim girl gave birth a male child namely SHUBHRANEEL DHALI, under the care of the complainant. After the birth of male child all of the accused persons brought MOON DEBNATH (DHALI) to her matrimonial home reassuring that she will not be subjected to cruelty ever again. Copy of the Birth certificate of the child (SHUBHRANEEL DHALI) is attached as annexure 3.

Accused persons again started to torture upon her due to demand of money and frequently the complainant fulfilled the demands of money with a hope for happy conjugal life of her daughter but irrespective of fulfillment of demands of accused persons, the accused persons did not stop torturing the victim girl.

10. That ultimately in the month of February 2020 the complainant goes to the local panchyat member of that area to stop torture of the accused persons above named upon his daughter and the accused persons assured the complainant in front of the local panchyat that they will never torture upon her (MOON DEBNATH DHALI) but the assurance was nothing but a lie as they never complied with whatever they have promised/ assured and started mental/ physical torture again




- It is pertinent to mention here that the accused No. 1 is a gamble addict and the money he regularly demanded was incurred for his expanses due to his habitual gambling.

The complainant above named beg to state as follows :-

- That the complainant above named is a law abiding, peace loving citizen resides within the jurisdiction of this Ld. Court. The Complainant is the father of the Victim girl namely MOON DEBNATH (DHALI).
- That the daughter of the complainant i.e. the victim girl MOON DEBNATH (DHAU)
 got married with the accused no. 1 namely Sanjay Dhali S/O sadanand Dhali on
 26/11/2017 as per special marriage Act. 1954 (vide certificate no. 258 dt.
 26/11/2017). Copy of the Certificate attached as Annexure 1.
- 3. That a social marriage solemnized on 04/12/2017 as per Hindu rites & customs at the above mentioned residential address of the complainant. At the time of social marriage there was a pressure of demand of dowry on the part of the above name accused persons and when the complainant expressed his inability to fulfill their dowry demands the accused persons, they threatened the complainant and his daughter to break down the marriage, therefore they made the complainant bound to fulfill their dowry demands.
- 4. That at the time of social marriage 4 pieces gold chains, 2 pieces of finger rings, 2 sets of earrings, 10 sets of nose rings, 1 piece almira, 1 wooden bed, 1 led TV, 1 show case many house hold articles etc and cash of rupees 3,20,000/- (Three Lacs Twenty Thousand only) had been given to the accused persons as per their dowry demand. Which are still in the possession of the accused persons. Copy of List of articles attached as annexure 2.

It is pertinent to mention here that at the time social marriage many valuable ornaments, articles, gifts and house hold articles had been given to the Moon Debnath (Dhali). This can be amounted as Stridhan Property which is still in the possession of the accused persons.
