Subject: Request for lodging FIR regarding Burglary attempt & Vandalizing of Onsite ATM of Union Bank of India, Ghughumali branch (ATM ID: HSIL50301111111)

Respected Sir,

With due respects it is informed that the Onsite ATM of Union Bank of India, Ghughumali branch was found tampered with by some unidentified miscreants. On further searching of CCTV footage available at Ghughumali branch it is discovered that on 26/02/2021 at around 01:30 hours (Mid Night)- some unidentified miscreant was trying to break open the ATM but could not be succeeded. However, the ATM got heavily damaged & non-operational.

One Security Guard is also deployed at the Onsite ATM during night time. However, the guard was absent during that time & the concerned private security agency in charge of M/s-SIS (India) Ltd. failed to discover the same. If the miscreants would have succeeded to break open the lock of the said Onsite ATM, there could be a major burglary incident & the possibility of the same cannot be ruled out.

In view of the above, it is requested that FIR may be lodged & oblige thereby.
