Sir,

In producing herewith one arrested accused person namely Dulal Sutradha (52) S/O Late Ratan Sutradhar of Dakshin Bharatnagar near Jora Bridge, Ward No. 24, PS- Siliguri, Dist-Darjeeling along with seized articles vize- i) 30 (thirty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal, ii) 03 (three) sealed bottles of Royel Choice 60 up country spirit containing 300 ml each Manufactured and bottled by Prokash Distillery & Chemical Co.(p) Ltd., Looksan, Jalpaiguri-735205 and iii) 03 (three) sealed bottles of Kingfisher strong premium beer containing 650 ml each brewed & Bottled by United Breweries Ltd. Vittal Mallya Road, Kalyani , West Bengal-741235.

SI Hiru Kanti Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Dulal Sutradha (52) S/O Late Ratan Sutradhar of Dakshin Bharatnagar near Jora Bridge, Ward No. 24, PS- Siliguri, Dist-Darjeeling to the effect that on 27.02.21 at 19.15 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at Jora Bridge, South Bharat Nagar under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Siliguti PS. As per his direction I along with SI Swadesh Saha, C/249 Madhav Chandra Roy and CV-513 Rajib Barman left for Jora Bridge, South Bharat Nagar under Siliguri PS vide Siliguri P.S GDE NO: 1578 to verify the veracity of the information. On reaching at 19.35 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot, but we managed to apprehend him and on interrogation, the above noted person disclosed his identity as noted above. On searching we found that i) 30 (thirty) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal, ii) 03 (three) sealed bottles of Royel Choice 60 up country spirit containing 300 ml each Manufactured and bottled by Prokash Distillery & Chemical Co.(p) Ltd., Looksan, Jalpaiguri-735205 and iii) 03 (three) sealed bottles of Kingfisher strong premium beer containing 650 ml each brewed & Bottled by United Breweries Ltd.Vittal Mallya Road, Kalyani , West Bengal-741235. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last eight (08) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure was made in between 21.15 hrs to 21.55 hrs. On being asked he stated that he used to sale the same to locality without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him U/S-41 Cr.P.C after observing all sorts' of rules for selling the said country made sprit without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Dulal Sutradha (52) S/O Late Ratan Sutradhar of Dakshin Bharatnagar near Jora Bridge, Ward No. 24, PS- Siliguri, Dist-Darjeeling under proper section of law and arrange for its investigate.
