I, SI Rantu Haldar (29), S/O- Manoranjan Haldar of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted accused person namely Jahida Begum(F/50) W/O- Osman Sikdar of Asrafnagar, P.O- Haidarpara, P.S- Bhaktinagar, Dist- Jalpaiguri to the effect that on 14.05.2022 at about 05.15 hrs I received a specific source input that one person, possessing huge quantity of 'Codeine Phosphate' based drugs, was standing at Anchal more under Bhaktinagar PS to sell the same to his designed customers. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

On way to Anchal more under Bhaktinagar PS I contacted two disinterested persons namely (1)Pravat Prasad S/O- Ram Prasad of Vivekananda nagar, Ward No 42, P.S Bhaktinagara, Dist- Jalpaiguri and (2) Dipak Biswas S/O- Gopal Biswas of Nimbu Busty, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with above noted independent witnesses arrived at Anchal more under PS- Bhaktinagar at 05.25hrs and subsequently, being pointed by my source detained 01 (one) person standing at Anchal more. She had carried one multi-colour nylon bag in her right hand. Thereafter, we disclosed our identity and the information in hand and stated her that she as well as the bag under her possession will be searched for the purpose. And, I gave him option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which she agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but she did not search the police party. Consequently, I informed the matter to I/C Bhaktinagar PS regarding the interception of the accused person suspected to be possessed 'Codeine Phosphate' based drugs illegally and requested him to come at Anchal more under Bhaktinagar PS to remain present and to supervise the search and seizure.

Accordingly at 05.55 hrs Shri Amaresh Singh I/C Bhaktinagar PS acting as gazetted officer of SPC arrived at the spot at Anchal more under Bhaktinagar PS as gazetted officer, SPC and in presence of two independent witnesses LC/1212 Nirita Lama searched the detained person following all formalities, keeping her decency and recovered the above noted article from the exclusive and conscious possession of the accused person namely Jahida Begum(F/50) W/O- Osmań Sikdar of Asrafnagar, P.O- Haidarpara, P.S- Bhaktinagar, Dist-Jalpaiguri

On being searched of the said detained person found 25 (twenty-five) bottles of "Cefrex" cough syrup (each bottle containing 100 ml) containing 25 X 100 ml = 2500 ml i.e., equivalent to 2.5 Kgs. which was kept into a nylon bag carried by the detained person namely Jahida Begum (F/50) W/O- Osman Sikdar of Asrafnagar, P.O- Haidarpara, P.S- Bhaktinagar, Dist- Jalpaiguri

Further, on demand in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer of SPC the detained person namely Jahida Begum(F/50) failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of 'Codeine Phosphate' based drugs beyond the prescribed

Thereafter, I seized the recovered 25 (twenty five) bottles [containing total 2500 ml i.e., equivalent to 2.25Kg] of "Cefrex" Cough Syrup from the exclusive and conscious possession of above noted accused person namely Jahida Begum(F/50) at the spot at Anchal more under Bhaktinagar PS under proper seizure list in presence of independent witnesses and Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer, SPC obtaining their signature and being acknowledged by the accused person.

Subsequently, I labelled and sealed the seized articles in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer, SPC and independent witnesses and the accused person namely Jahida Begum(F/50) The whole process of seizure was made in between 06.45 hrs to 07.25hrs.

Being further asked, the apprehend persons namely Jahida Begum(F/50) admitted in presence of Shri Amaresh Singh I/C Bhaktinagar PS, SPC detailed for gazetted officer of SPC and other independent witnesses that She has procured the 'Codeine Phosphate' based drugs clandestinely for the purpose of selling the same in high rate to his designed customer for his personal gain by illegal means. She also disclosed that She has been dealing in this business of procuring and selling of 'Codeine Phosphate' based drugs illegally for last lew months for his wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Jahida Begum(F/50) is involved in procuring and selling 'Codeine Phosphate' based drugs illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused person namely Jahida Begum(F/50) W/O- Osman Sikdar of Asrafnagar, P.O- Haidarpara, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person Jahida Begum(F/50) W/O- Osman Sikdar of Asrafnagar, P.O- Haidarpara, P.S- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
