I the undersigned would like to inform you that I am a bonafide tenant in respect of a shop-room situated at Chayan Para, Ward No. 37 of S.M.C., Dist. Jalpaiguri. Very recent my landlord Sri Kamal Paul in collusion with the Branch Manager of State Bank of India, Sevoke Road, Siliguri forcibly put the pad lock on the main entrance of my shop-room keeping all my valuable articles there with an intention to evict me from the said shop-room without due process of law.

taking that advantage they all have look opportunity to evict me from my shoproom by violating the injunction order of the Ld. Court.

Under the above circumstances being a helpless poor tenant I would like to humbly request you to protect my interest as a tenant of my shop-room as per the order of the Ld. District Judge, Jalpaiguri otherwise I will face the starvation with my family members and for this act of kindness I will be much obliged.
