In producing herewith o3 (three) arrested accused persons namely 1) Rajesh Gupta (33 yrs) S/O- Sri Lalu Gupta of Bottle company, Jyotinagar, ward No- 41, 2) Suresh Thapa (42 yrs)S/O- Late Dilbahadur Thapa of Prakashnagar, Wadr no- 42 and 3) Sukhlal Gurung (45 yrs) S/O- Late Budhiman Gurung of Limboo Busty, Ward no- 42. all of PS- Bhaktinagar, Dist- Jalpaiguri along with seized of cash Rs. 600/- and one Mahendra Pick-up Van nearing no- WB73 D/7503.

I beg to report that, I SI Dwipendra Nath Bakshi of Bhaktinagar PS,SPC do hereby lodged this complaint against the above noted accused persons namely to the effect that, on 14/9/22 during my K-37 II Mobile Van duty under Bhaktinagar PS area vide GDE No 584 dated 14/9/22, I received an information that few persons collecting money forcefully from the Drivers of Vehicles at Sevoke Road in front of Kendriya Vidyalaya under Bhaktinagar PS. Accordingly, I informed my I.C. Bhaktinagar PS and as per his direction, myself along with my accompanied force Viz- C/512 Dharma Mohan Roy, C/410 Mantosh Singh, vide Bhaktinagar PS M.C.C No-1244/22 dated 14/9/22. At about 19.35 hrs we reached at Sevoke Road in front of Kendriya Vidyalaya and found the above noted arrested accused persons and 3/4 persons were collected money from the Drivers of vehicles forcefully. We are apprehended the above noted three accused persons and others managed to flee away from the spot. On being interrogation, the above noted accused persons admitted their guilt before the Police and further stated that they were collected money from the Drivers of vehicles forcefully for their wrongful gain putting person in fear of injury. On being search, I recovered [i] Cash of Rs. 600/- (Six hundred) only which they collected from the drivers of vehicles forcefully, [ii] 15 numbers of Subscription Slips in the styled as Sri Sri Biswakarma Puja, organized by Siliguri Sikkim NH-10 Truck Drivers Association, Prakash Nagar, 3rd Mile Sevoke Road, Ward No- 42, Siliguri and one Mahendra Pick-up Van nearing no- WB73 D/7503 which was they used during their collection.

Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted three accused persons u/s- 41 Cr.P.C.

Under these circumstances, I pray that stern action may kindly be taken against 1) Rajesh Gupta (33 yrs) S/O- Sri Lalu Gupta of Bottle company, Jyotinagar, ward No- 41, 2) Suresh Thapa (42 yrs)S/O-Late Dilbahadur Thapa of Prakashnagar, Wadr no- 42 and 3) Sukhlal Gurung (45 yrs) S/O- Late Budhiman Gurung of Limboo Busty, Ward no- 42, all of PS- Bhaktinagar, Dist- Jalpaiguri and 3/4 others initiating a specific case under proper section of law.
