Respected Sir / Madam,

I Smt. Rinky Sha, W/o. Sri Raju Show, D/o. Sri Jagdish Sha, R/o. Haiderpara, Ward No. 40, Ghogni More, P.S. Bhakti Nagar, Dist.Jalpaiguri, would like to inform you that due to some misunderstanding between me and my husband we started to live separately since 2015 thereafter due to my working purpose I and my minor daughter namely, Riddi Show came to Siliguri and took shelter at the above noted rented house and after that in the year of 2018, I meet with a person namely **Joydev Sarkar**, S/o. Jitendra Sarkar, R/o. Dinhata, Modak Para, Ward No.03, P.S.Dinhata, Dist.Coochbehar and at that time he introduced himself as a business man and told me that he came to Siliguri frequently for business purpose and he also told me that he wants to make friendship with me and after few days I accepted his said friendship and thereafter he started to contact with me over telephone and after few days of our telephonic conversations suddenly he told me that he started to love me and he proposed me and after few days I accepted his proposal and during that time the above noted person promised me several times that he will marry me shortly and after giving me said promised he started to come at my above noted residence and started to make physical relationship with me at regularly basis and during that period his family members namely, **Jitendra Sarkar** and his sister namely, **Smt. Tanu Sarkar** also visited my house and they also assured me that they will arrange marriage ceremony of me and the above noted person as early as possible and after listening the same I started to trust him more and during this period he frequently started to come into my room and make physical relationship with me and when I denied to do the same at that time he gave me false promise of marriage after that he committed physical relationship with me. It is also important to mention here that during that period I was pregnant and at that time the above noted person pressured me to miscarriage the said baby and when I denied at that time he started to blackmailing me told me that if I do not miscarriage the said baby then he will never marry me and after listening the same I was shocked and due to my reputation or better future and also due to pressured by the above noted person I was compelled to took medicine / PIL and for that reasons my baby was miscarriage and after the aforesaid incidents I several times requested him to marry me but he always denied the same after giving me some silly issues and it is also important to mention here that I also requested his above noted relatives to arrange marriage ceremony but this time they also threatened me with dire consequences and told me that not to disturb the above noted person namely, **Joydev Sarkar** and they also offered me to take some money from them and leave him alone and when I protested the same at that time the relatives of the above noted person told me over telephone that they will come to Siliguri and give me a proper lesson after listening the same I immediately intimated the aforesaid facts to the above noted person namely, **Joydev Sarkar** but this time also he did not pay any heed to my intimation and during this period he several times tried to make physical relationship with me but I denied to do the same but at that time he show me some videos and naked photographs of me into his mobile phone and also told me that if I do not make physical



intercourse with him then he will spread the same to other people and also circulate the same in whatsapp or social media websites of my relatives and after giving me the aforesaid threat the above noted person namely, Joydev Sarkar several times committed rape upon me. Ultimately, on **03/10/2022** the above noted person came to my room and once again pressured me to make physical relationship with him and when I denied at that time he assaulted me with fists and blows and forcefully committed rape upon me and during that time he told me that he circulated my naked videos and photographs with his friends namely, **Dhiren Biswas, Joydev Modak, and Boni Biswas** and also told me that I also make physical relationship with them and he also circulated my phone number with them and after the aforesaid incidents I contact with his relatives namely, **Jitendra Sarkar** and his sister namely, **smt. Tanu Sarkar** and narrated all the incidents and also requested them to tell him that not to circulate the naked videos and photographs of me with other people but they did not pay any heed to my said requests and during that time they told me that they also have said videos and photographs in their mobile phone and also told me that if I take any legal actions against them then, they will circulate the same to the public in general and right now the above noted person namely **Joydev Sarkar** also over telephone threatened in respect of the above noted issues so right now I spend my days within fear and for that reasons no other alternatives way with the help of my well-wishers I lodge this complaint against the above noted persons.

It is therefore, I request you please take necessary legal action against the above noted persons and also save my life from their hands as early as possible.
