Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 737 dated 16.11.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/116 Rohit Kumar Mahato, HG/794 Ranjit Roy, CV/306 Biswajit Roy all of NJP PS, SPC left for South Colony bazar area, PS- NJP, Dist.- Jalpaiguri to work out the information in hand.
