Respected Sir,

I, Sri Raghu Majhi, son of Late Pandu, resident of Patharghata, Siliguri, Jhaguri. Chmta, New Champta District: Darjeeling being a member of Schedule Tribe do hereby lodge this complaint against the following accused persons namely:

- Krishna Singh, son of Late Kishori Singh, resident of Jhouguri, Police Station: Matigara, District: Darjeeling.
- (2) Raju Singh, son of Late Kishori Singh, resident of Jhouguri, Police Station: Matigara, District: Darjeeling.
- (3) Smt. Suchinta Majhi, wife of Dipak Majhi resident of Moharagaon Tea Estate, P.O -Sukna, P.S Pradhan Nagar, Dist Darjeeling.

With due regard I the above-named petitioner most respectfully beg to states for your kind attention and consideration in the following facts as under: -

- (i) That one Smt. Kailu Majhi since deceased wife of late Budhua Majhi is/was the recorded owner of the below schedule of land measuring 94 satak recorded in Khatian No. 7 mouza- Jhouguri and the names of the legal heirs are mentioned in the said Khatian and the said Smt. Kailu Majhi is my forefather.
- (ii) That on 16/12/2022 at about 3:30 the Accused persons no. 1 & 2 along with their associates forcefully entered into our land and started to erect the boundary walls and started ploting but after getting information about the incident I with my son immediately came to the spot but they assault us and there was altercation and scuffling and they left the place with threatening to us for dire consequences.
- (iii) Thereafter once again on 18/12/2022 at about 4:30 P.M. the Accused persons no. 1 & 2 along with their associates forcefully entered into our land with JCB Tractors and damaged our land and tried to grab our said landed properties but after getting information about the incident we

immediately came to our said land and strongly opposed them, then they started to threatening to us saying that they would take the possession of our land and if any obstruction is done they would assault us even if necessary they would kill us.

- (iv) That after that on 20.12.2022 I file a complaint before the Officer-In-Charge, Matigara but they refused to lodge a complaint and on 21/12/2022 the plaintiff send the complaint by Speed Post to the I.C Matigara and on the same day plaintiff lodge a complaint to the Superintendent of Police, Siliguri but no case has been registered. Lastly one Misc Case No. 4 of 2023 has been filed at Additional Chief Judicial Magistrate at Siliguri.
- (v) But despite such complaints the accused persons on 12/01/2023, 13/01/2023, 14/01/2023 by using their muscle power criminally trespassed the schedule land and are trying to construct therein and while I opposed them they started threatening me with filthy language. They even went ahead with name-calling me for belonging to the lower caste category. The accused persons called me untouchable and that if I made any attempt to enter and stop their construction I would face consequences.
- (vi) That the complainant came to know from the local people that the accused person no. 3 sells the schedule plot of land to on Tetenga Saibo as falsely portrayed to be the daughter of Kailu Majhi and Budhua Majhi vide false deed no 9121/2021, where there is no such document to show that the accused person no. 3 is the daughter of Kailu Majhi and Budhua Majhi or any legal heir Certificate.
- (vii) It is pertinent to mention here that the none of legal heirs of Smt. Kailu Majhi was/is sold or transfer any part from that land.
- (viii) It is therefore crystal clear that the accused persons entered into a criminal conspiracy and had prepared forged documents with malafide and dishonest intention and also using as genuine a forged documents which is known to them as forged and the said accused person no.3 made fraudulent execution of deed of transfer containing false statement and on the strength of those forged document criminally trespassed into our land but could not be able to take possession and left away. Those accused persons wrongfully tried to disposes me and interfere with the enjoyment of our rights over our land. These accused persons also gave false and fabulous information to the officer in their engaged antisocial who are always moving around our land and helpless Schedule Tribe.

(ix) It has been threatened by them that If we oppose them there is every possibility for losses our lives and properties by the above named accused persons as because they were anti-social in nature and they have no regards about the law of the Country.

Under the above circumstances it is humbly prayed to your good self to be kind enough to accept this F.I.R and to take necessary strict and vigil action against the above noted accused persons and to save us and our properties as from the clutches of accused persons for the end of justice and also arrest the above noted accused persons.
