Respected Sir,

With due respect I, Parimal Thapa, Son of Kamal Thapa, resident of Kholachand Fapri, P.O. Baikunthapur, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal would like to state that my brother i.e. Nitesh Thapa, Son of Kamal Thapa, and Bivek Chhetri, Son of Kazi Chhetri, both are resident of Kholachand Fapri, P.O. Baikunthapur, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal was travelling from Kholachand Chand Fapri to Siliguri vesterday-i.e. 28.03.2023 at around 10 pm and near the Kholachand Fapri bridge one Yamaha R15 motor cycle bearing number WB 70 L 3450 coming in high speed and showing stunts hit the Jupiter Scooter WB 74 AZ 8258 riding by brother and his friend. The persons riding the said motor cycle were in a serious drugged and drunken condition and were driving the said bike recklessly and negligently in a high speed. Due to such dangerous and life threatening display of recklessness the accident led to some serious injuries on the left foot and knee of Vivek Chhetri and the left foot of Nitesh Thapa. The legs of both the aforesaid persons are fractured and needs intensive treatment to be good again. The aforesaid persons are presently admitted at the Nayak Hospital at Sevoke Road. The person riding the said bike were Rahul, Son of Not Known and Gautam, Son of Not Known, both are resident of Ektiasal, P.O. Sevoke Road, P.S. Bhaktinagar, Dist -Jalpaiguri, West Bengal and are spoiled and dangerous persons. Both of them and some other persons regularly hang around that area and consume alcohol and drugs and show stunts in their motor cycles. The aforesaid persons are a menace to our society and are persons that need serious rehabilitation. Due to their thoughtless stunts and driving, such incident was bound to occur some day. The condition of my brother and his friend is

not good and are in serious mental and physical pain. The traumatic experience of the injury shall follow soon. The aforesaid persons should be punished and the injury should be compensated as the legs and the experience of my brother and his friend will never remain the same. I could not lodge this FIR within 24 hours of the incident as because I was busy with the treatment of my brother and his friend.

So I therefore request you to look into the matter and do the needful and lodge a specific case against the aforesaid person as they are dangerous and for the pain and injury suffered by their doing.

I shall be highly obliged for this act of kindness.
