I Anamika Singh, Wife of Manish Panday, resident of Bagajoti Colony, 45/5, P.S.- Pradhan Nagar, Dist:- Darjeeling, begs to report you the following:-

- That I got married to Manish Panday on 28/05/2023 as per hindu rites and customs and the said marriage was a arrange marriage.
- 2. That at the time of marriage I was in 3rd Semester, B.Com. in Siliguri College pursuing my degree course and I has asked my husband weather I can come to my home town to write my exam to which my husband agreed at the time of marriage but when my exams were approaching an I ked my husband to take me to my home town so that I can write my exam but he started denying to take me to write my exam and further started quelling with me in pity issues and use to confine me at home so that I done go to write my exam.
- 3. That my father is no more in this world and my widow mother raised me alone with many difficulties and even after all such difficulties my mother fulfilled all the demands as asked by my husband and my in-laws.
- 4. That in my marriage my mother gave 2 (two) gold rings, 2 (two) gold ear ring, 1 (one) Nose Pin, 2 (two) silver anklet, wooden bed, wooden dining table, 4 (four) wooden chairs, Almira of Godrej, wooden cubbed, and Rs. 1,00,000/- Cash as demanded by my husband and in-laws.

5. That immediately after my marriage behavior of my in-laws and my husband changed drastically, initially I did not understand but when I tried to find out I came to know that my in-laws were getting more dowry from some other girls family and immediately after that things and behavior changed towards me but when I came to my above mentioned address to write my 3rd Semester exam in Siliguri College after requesting my husband to let me go to write my exam as it it my dream to complete a degree, after my husband agreed he himself came to drop me at my place on 10/07/2023 but my exams were suppose to start from 28/07/2023 but I came early to prepare for my exam on 10/07/2023, I came to know from the relative of my husband side that he is having extra marital affair with many other women after I left my in-laws house to write my exam at first I was shocked to hear that and did not believe them but they send me a videos of my husband with some other women in a obscene situation and a situation where no wife would ever want her husband to see in that situation after all this when I called my husband to asked a clarification about the said video he started abusing me in filthy languages and also threatened me with dire consequences and said me that if I am coming back to my in-laws house he won't let me go anywhere else and will also confine me again in a room after hearing I disconnected his call in the mean time he started threatening me over the phone and text messages, my father in-law and mother in-law also started threatening me with dire consequences and also said me if I don't leave everything and come back home then they will file a false case against me and my entire family.

6. That on 01/08/2023 after all this my husband and my mother in-law namely Godawari Devi and my father in-law namely Agni Jyoti Panday along with brother of my father in-law namely Pramod Panday came down to my above mentioned address and started abusing me in filthy languages and even threatened me that if I do not go back with them at that very moment then they would put false allegations of running away with huge amount of gold and cash from their house. When I disagreed to go back along with them then my said husband pushed me hard against the wall and strangulated me with his hands having the intention to kill me at the spot as I was not ready to go with him back to my in laws house. While strangulating me he even tried to tear open my clothes with the intention to disrobe me in front of my in laws and my family. While all this was happening I tried to raise hue and cries but do my dismay no one present there helped me. I tried to rescue myself from his clutches and ran out to save my life, after which he along with his family left my maternal house, but before leaving they told that if I did not return back to my in laws house within a week then they would implicate me in false cases and also get me killed where ever they find me or if my family tries to get a divorce and get me married to someone else then they would kill that boy along with me and my family.

- 7. That the brother of my father in-law is repeatedly threatening me of dire consequences if I don't return back to them silently and without any issues and problems.
- 8. That I could not lodge this FIR against them in the due time as I was hiding from them in a fear that they will take me forcefully with them as they have already tried to do so and I was trying to save myself from the

clutches of my husband and my in-laws as they are having the intention to kill me and demand huge sum of money from my widow mother.

9. That my husband and his family members are very dangerous in nature and are having the intention to grab huge sum of money from my mother as dowry and take me back home so that they can mentally and physically torture me and keep demanding huge sum of money every now and then.

I therefore request you to kindly take necessary legal action against the aforesaid culprits.
