Sir,

In producing herewith two accused persons namely (1) Sanjay Singha (23 years) S/O Mangal Singha of Jay Singha Jote, Naxalbari PS Naxalbari Dist. Darjeeling and (2) Padya Singha @ Bikram S/O Late Nirod Singha of do under custody and the following properties under seizure ----

(1) 50(Fifty) bottles of "PHENSEDYL" TRIPROLIDINE HYDROCHLORIDE & CODINE PHOSPHATE COUGH SYRUP, each bottle containing 100 ML, Manufractured by ABBOTT HEALTHCARE PVT, LTD, B-NO-PHD23070, MFD-SEP/2023, EXP DT.NOV/2023, MRP-Rs.205.48/-, (each bottle containing Codine phosphate 10 mg & Triprolidine Hydrochloride 1.25 mg) which was kept in a one black coloured School bag marked as exhibit "A-1". One bottle taken from exhibit "A-1" as sample marked as exhibit "S-1".

(2) One red coloured Pulsar 125 Motor cycle bearing registration no. WB74/BN-6483 with key.

Marked as exhibit - "B-1"

Seized the above noted articles from the joint possession of accused Sanjay Singha and Paddo Singha @ Bikram

I, S. I. Swapan Kr Ghosh S/O Late Shib Ranjan Ghosh of Ashighar OP P.S. Bhaktinager SPC, do here by lodge this complaint to the effect that on 27.11.2023 at 13.05 hrs. I received a secret source information that two notorious drug peddlers namely Sanjay Singha and Padya Singha @ Bikram are now standing near Tharughati bridge Ashighar, riding on a Motor Cycle with one bag of restricted Narcotices drug in their possession in order for its clandestine disposal at Ashighar area. Accordingly, I diarised the matter vide Ashighar OP G.D.E. No. 667 dated - 27.11.23 and informed the matter to O/C, Ashighar OP and as per his kind instruction myself along with ASI Prasenjit Barman, ASI Tapan Kr Roy and C/973 Kushal Roy and CV/1016 Amrit Roy all are of Ashighar OP left for near Tharughati bridge area, in a Govt vehicle along with weighing machine & investigation kit and Video Grapher at 13.15 hrs. to verify the veracity of the information vide Ashighar OP G. D. E. No. 668 Dated - 27.11.23. On way to near Tharughati Bridge area. I called two independent witnesses namely [1] Mithun Adhikary (25) S/O Late Kanai Adhikary of Chayanpara Ashighar PO Ghogomali PS Bhaktinager Dist. Jalpaiguri and [2] Subodh Roy (35) S/O Moti Roy of Purba Chayanpara PS Bhaktinager Dist Jalpaiguri and informed them about the information in hand and requested them to accompany us to witness for search and seizure if necessary. At about 13.35 hrs. myself along with my accompanying party arrived near Tharughati Bridge area and contacted with my source. At 13.45 hrs. as identified by my source myself along with my accompanying party cordon the above noted accused persons those were standing riding on a red coloured Motor Cycle and a black coloured School bag kept with the Motor Cycle and waiting for someone. On being asked they disclosed their identify as noted above. On being further asked they stated that the content inside the black coloured bags in their possession some restricted Narcotics drugs which they intend to sell in Ashighar area. After disclosing our identity, I asked them whether they have any objection to be searched in presence of any Executive Magistrate or Gazetted officer and they agreed to be searched in presence of any Gazetted Officer. I served them a notice in accordance with the provisions of law in this regard. Then at 13.55 hrs. 27.11.2023 I apprised Shri Rajen Kumar Chetri, ACP, DD, SPC and requested him to remain present at the spot as Gazetted Officer. At 14.35 hrs. Shri Rajen Kumar Chetri, ACP, DD, SPC, arrived at the spot. I disclosed the identity of Shri Rajen Kumar Chetri, ACP, DD, SPC to the accused persons as Gazetted Officer. Under supervision of Shri Rajen Kumar Chetri, ACP, DD, SPC and the above noted witnesses the aforesaid accused persons and the above noted black coloured bag were searched keeping strict regard of their decency and recovered the above articles. They further confessed in presence of Gazetted Officer and other witnesses that they procured the said restricted Narcotics drugs from Siliguri clandestinely for the purpose of its selling with a view to earn

huge money quickly. On interrogation they disclosed that they have been dealing in such business for last few years importing it from Siliguri and selling the same at Ashighar and its adjacent areas. On being asked they failed to produce any documents or license in support of their possession this restricted Narcotics drug. Then as per direction of Shri Rajen Kumar Chetri, ACP, DD, SPC. I counted and found 50(Fifty)bottles of "PHENSEDYL" TRIPROLIDINE HYDROCHLORIDE & CODINE PHOSPHATE COUGH SYRUP, each bottle containing 100 ML, Manufractured by ABBOTT HEALTHCARE PVT, LTD, B, NO-PHD23070 MFD-SEP/2023, EXP DT.NOV/2023, MRP-Rs.205.48/-, (each bottle containing Codine phosphate10 mg & Triprolidine Hydrochloride 1.25 mg), which was kept in a one black coloured School bag marked as exhibit "A-1". One bottle taken from exhibit "A-1" as sample marked as exhibit "S-1". Then, I packed, labeled and sealed the bag in presence of witnesses, and seized the above noted recovered restricted Narcotics drug and Motor Cycle bearing registration no. WB74/BN-6483 by which they carring the said restricted Narcotics drug as Alamat under proper seizure list under the supervision Shri Rajen Kumar Chetri, ACP, DD, SPC duly signed by the local witnesses and the accused persons. The seizure was made in between 14.45 hrs and 15.35 hrs. Then, I arrested the above noted accused persons after observing all formalities of arrest as well as after disclosing the cause of arrest and issued necessary memo of arrest duly signed by the accused persons and witnesses. The copy of seizure list and memo of arrest have been supplied to the above noted accused persons under receipt. Thus, the accused persons violated the terms and conditions of N. D. P. S Act. for possessing this restricted Narcotices drug without any legal authority. The videography has been done of whole process by videographer.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Sanjay Singha (23 years) S/O Mangal Singha of Jay Singha Jote, Naxalbari PS Naxalbari Dist. Darjeeling and (2) Padya Singha @ Bikram S/O Late Nirod Singha of do and arrange for its investigation.
