I Jhuma Sarkar, wife of Debraj Sarkar, residing at Matigara Police Station, Post Office -Kadamtala, under Police Station -Matigara, District -Darjeeling, would like to inform you that, yesterday night at about 00.30 hours (approx) one Pratim Saha @ Bappa, son of Prafulla Saha, residing at C/O Sastha Sundor, near Ghosh Printing Press, Military Road, Shivmandir, Post Office -Kadamtala, under Police Station -Matigara, District - Darjeeling suddenly came in front of our house in a heavily drunken condition and started shouting in abusive and filthy language. He was continuously threatening loudly to kill my husband in abusive language and was continuously kicking the iron gate of our main entrance with an intention to break open it to forcibly intrude in our house which was also creating loud noises. When I went in front of my main gate and requested him to leave, said Pratim Saha @Bappa abused me physically, assaulted me with slaps and kicks and outrage my modesty by trying to disrobe me. At this, when I screamed loudly being helpless, hearing which my husband came for my rescue, then said Pratim Saha @Bappa picked up a brick and threw it over my husband's head with great force with an intention to cause his death. Hearing our hue and cry, when the neighbours came out of their houses, said Pratim Saha @Bappa fled away. Be it pertinent to mention here, my father -in -law, who is a senior citizen and suffering from several ailments, also got traumatized by the incident and has fallen severely sick due to this incident.

Therefore, I request to your good office, kindly investigate the matter and take necessary actions and set the law of the land in motion and impart me justice.
