Dear Sir,

I would like to draw your kind attention to the following fact in the manner: -

- 1. That I am the sole and absolute owner of a plot of land measuring about 2.07acers more or less lying situated at mouza kalkut, L.R dag No. 379,381,382, and L.R khatain N.O.-2096, J.L N. O 44, Touzi N.O 91, Pargana Pathar Ghata, A.D.S.R- Siliguri –ii, P.s Pradhan Nagar, District Darjeeling.
- 2. That I want to construct a boundary wall in and around of my said plot of land to avoid any dispute and difference with some local people in the local area of Pradhan Nagar who are always trying to occupy part and portion of said plot of land forcefully.
- 3. On 6 th september,2024,as per the honourable high court order of removal of pipeline,the pipeline was removed and on the same date while I was in the process of constructing a boundary for my land, Over the point,through which the noted person trespasses, the noted person gathered instantly by noticing the costruction of the boundary, and tried to encroach upon, and also tried to assault my son and the masons whom I have engaged for the construction of the wall.
- 4. That I made an intimation application on 14.11.24 before the Pradhan, within Champasari Gram Panchayat for the purpose of construction of a boundary wall in and around of my said plot of land as per law of land.
- 5. That I have engaged mason and labors for the purpose of construction of a boundary wall in and around the said plot of land on and from 14.11.24 at about 11 O'clock, then above stated persons came into the said plot of land and raised objection to mason and laborsand forced them to stop the construction of the boundary wall on the said plot of land and thereafter when I protested them and said that I am the owner of this plot of land and I made an application before the Champasari Gram Panchayat for the purpose of the construction the boundary wall on the said plot of land and I further told them that

they have no right to stop my construction work to build the boundary wall and asked them to leave the place. But thereafter they assaulted my son Rahul Guha. They further threatened me and my son with dire consequences if I try to construct the boundary wall along my land.

In the circumstances I most respectfully beg before you good office to kindly look into the matter and please take necessary step against the above stated person by registering a F.I.R. in accordance to law.
