I was running inside the kitchen to save my life but they forcefully went into the kitchen and attacked me with whatever they got near their hand. Some of them used frying pan to hit me on head, Some of them used utensils, one of them used butcher chopper and gave cuts on my back side and random punches on faces, head and back by everyone. They tear off my clothes and Spilled hot oil on my body and left side of my face.

Kindly do the needful as soon as possible. I want to lodge a FIR against the assault happened with me.

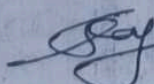
