

I, Shri Ranjan Sarkar, S/O Ameresh Ch. Sarkar, R/O Shivmandir Road, Subhash Pally, Siliguri, Advocate by occupation, designated as Deputy Mayor of Siliguri Municipal Corporation, bringing it under notice to your good office about my experience of immense trauma and fear of losing life. I, at 4 p.m. yesterday (15/03/2025) went with one of my dear ones to Nivedita Nursing home after being informed about the demise of the mother-in-law of my sister. At the time my car was passing through Hill Cart Road near hotel Vinayak a group of miscreants blocked my path and hurled into my car windshield and punched the bonnet. The group of miscreants stopped my vehicle and shouted with slang and climbed up the bonnet. After this I stepped out of the vehicle and this is when they grouped up against me. I gently asked the group about their unreasonable behaviour and to leave my path. In retaliation they said that they came from Bihar, and the rest of them are locals and they agitated my request by stating loudly "mar du kya?" which in simple terms meant a warning to kill me. After such an untoward incident I found no other alternative and decided to leave the area somehow.

Therefore I earnestly request your good office to kindly enquire the whereabouts of such miscreants and for what reason they came in a group to block my path, attack me and threaten me to death.
