Chandradeep Prasad, resident of Near Khatu Shyam Mandir, Santoshi Nagar, Ward No. 5 SMC, P.O. & P.S.-Siliguri, Dist.-Darjeeling (W.O.), beg to inform you that on dt. 15.03.2025 at about 07:30 pm, I saw that my neighbour namely Suraj Poddar and Gopal Poddar, both sons of Sri Ram Lakham Poddar, were fighting amongst themselves near their house at Santoshi Nagar, as usual and said Suraj Poddar was brutally beating his younger brother namely Gopal Poddar with fist and blows and suddenly said Suraj Poddar brought a metal frying pan, and at the hit of the moment he started hitting strongly to his younger brother, Gopal Poddar with that metal frying pan on his head and different part of the body and the said Gopal Poddar became unconscious and fell on ground and shifted to Siliguri Dist.Hospital and admitted there in serious condition.

Later on concerned medical officer declared, the victim Gopal Poddar, dead.

Therefore please take necessary action against said alleged person namely Suraj Poddar S/O Sri Ram Lakham Poddar of Near Khatu Shyam Mandir, Santoshi Nagar, Ward No. 5 SMC, P.O. & P.S.-Siliguri, Dist.-Darjeeling (W.O.)
