Subject: F.I.R

Sir,

With due respect and humble submission I SI Ramanath Karjee of Matigara P.S do hereby lodge this written complaint to the effect that today on 16.03.25 I was deputed to perform K-33 night Mobile Van duty along with force, since 22.00 hrs vide Matigara P.S. C.C. No. 02/25, Dated 17.03.25 and Matigara P.S. GDE No. 915, Dated -16.03.25 in course of said K-33 night mobile van duty I received source information that one Mazda Truck is loading river bed materials at Bashbarighat under Matigara PS. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at Bashbarighat under P.S.- Matigara and found that one Mazda Truck bearing Reg. No. WB 73 D-5576 loaded with river bed materials standing at Bashbarighat. On seeing the Police team the driver of the vehicle tried to flee away but somehow we apprehended him. On demand he could not produce any valid documents in support of said river bed materials and the documents of the said vehicle. It is crystal clear that the driver/owner of the vehicle Mazda Truck bearing Reg. No. WB 73 D-5576 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to their designated customer for their wrongful gain.

Finding no other alternatives, I seized the said vehicle Mazda Truck bearing Reg. No. WB 73 D-5576 loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S and arrested the driver namely Debilal Thami S/o Mangal Thami of Magalpuri, Po+PS-Darjeeling Sadar, Dist- Darjeeling. The seizure was made in between 00.13 hrs to 00.21 hrs on 17.03.25.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/ owner of the seized Mazda Truck bearing Reg. No. WB 73 D-5576 and arrange for its investigation.
