I, Sri Sameer Darnal, son of Late Ganesh Darnal, resident of Kafobar, Kurseong, presently residing at Debidanga, Post Office - Champasari, Police Station - Pradhannagar, District - Darjeeling, Pin - 734003, would like to inform you that on 14.03.25 at around 8:30 PM - 9:00 PM, my younger brother Sri Vivek Darnal, while he was going for a walk after dinner, an unknown vehicle at overspeed crashed with my brother due to which his right leg got completely fractured. Getting the information I immediately reached the site of accident but before I could get them, they fled from the site and became untraceable. Seeing the situation of my brother Sri Vivek Darnal getting worse, I immediately rushed him to NBMCH Hospital, Siliguri and as such he is admitted there on emergency. I ascertain that they were drunk and were riding the bike/scooty at overspeed due to which my brother Sri Vivek Darnal got grievously injured. I, therefore request you to kindly investigate the matter and book the culprits under appropriate provisions of Criminal law.
