On **15.03.2025 in the night at 9 P.M.**, I was assaulted, abused, and beaten in a group on the road by the following individuals:

3. **Smt. Sampa Adhikari**

These individuals not only physically attacked me but also engaged in theft and other unlawful activities. The incident took place at **Vivekananda Nagar, Ward No. 42 of S.M.C., P.O. Salugara, P.S. Bhakti Nagar, Dist. Jalpaiguri, West Bengal - 734008**.

Several **local people** witnessed the incident, and I am willing to provide further details if needed. Given the seriousness of the offense, I request you to take **immediate and strict action** against the culprits as per the law to ensure justice and my safety.

I hereby request you to register my complaint as an FIR and take necessary legal action against the accused.
