With due respect, I ASI Paresh Nath Chowdhury of NJP PS in producing herewith the two arrested accursed persons namely 1. Rafikul Islam, (22 yrs) S/o Md Sanibullah 2. Mahiul Karim @ Pappu (38) S/o Lt. Fazlul Karim both of Amaidighi, Fulbari PS NJP Dist. Jalpaiguri do hereby lodged this complaint against them and also against accused namely 1. Md Nur S/o Abdul Haque 2. Miraj and 10/15 others to the fact that on 16.03.25, myself along with force while performing Night Spl Van Duty vide GDE No. 805 dated 16.03.25 and MCC No. 234/25 dtd. 16.03.25, received an Information from duty Officer SI Rana Bhahma on 17.03.25 at about 00:45 hrs on-duty officer received information over phone through mobile no 8918821331 informing that one thief has been caught at Amaidighi (near TVS show room) while his other associates has fled and requested immediate police presence, which was diarised vide NJP PS GDE NO. 810 dt. 17.03.25. Accordingly as per direction I alongwith force immediately rushed to the spot and reached there at 00-55 hrs. On reaching there found that one apprehended person was been assaulted with lathi by the public. Seeing this, we tried to rescue the said apprehended person from been further assaulted and could have been killed by the mob, but in course of rescuing him from the mob, they heckled and obstructed the police personnel on duty with aggressive mood and started using abusive and filthy languages against the on duty police personnel. I alongwith others police personnel tried to persuade them repeatedly not to obstruct in our Govt. duties, but they did not try to understand anything and became more violent and started scuffling with us. They also assaulted me and other on duty police personnel, as a result I alongwith other police personnel sustained injuries on our bodies. Accordingly, I informed the matter at PS and thereafter, SI Sunil Gurung along with reenforcement came to the spot at 01-35 hrs .On reaching there , the accused persons started to fled away, but we managed to apprehended the above noted two persons namely 1. Rafikul Islam, aged 22 yrs S/o Md Sanibullah 2. Mahiul karim @ Pappu (38) S/o Lt. Fazlul Karim both of Amaidighi, Fulbari PS NJP Dist. Jalpaiguri ,but the others managed to flee away from the spot out of which we can identified 1. Md Nur S/o Abdul Haque 2. Miraj and there were other 10/15 male persons. We rescued and recovered the said apprehended person from their custody. On interrogation of person said to be thief, it's found that he is a vagabond and on examination he disclosed his identity as Binod Paskuti Dhamai (37) s/o Tara Bir Darjee of Vill. Tapu, Ps & Dist Illam ,Nepal (but not verified). He gave incoherent statement regarding his identity and it seems that he was not on his good mental state, but the process for his identification is going on. He was taken to NJP PS for his safety and provided food and shelter as he is not been able to provide his address and any phone number. I then alongwith force went to Siliguri District Hospital for getting medical treatment, copies of medical slip is attached herewith.

I, therefore, pray before your honour that necessary action as per law may kindly be taken against above noted two arrested person 1. Rafikul Islam, aged 22 yrs S/o Md Sanibullah 2. Mahiul karim @ Pappu (38) S/o Lt. Fazlul Karim both of Amaidighi, Fulbari PS NJP Dist. Jalpaiguri and 3. Md Nur S/o Abdul Haque 4. Miraj and 10/15 others.
