This is for your kind information that I, Sanny Manna, Intern doctor at North Bengal Medical College was assaulted by some of my seniors and batchmates. I went to receive my show cause letter from the academic section after that I was having an interaction with our dean madam regarding this when,

These students, led by -

Dr Md Sahadat Islam, housestaff, dept of Surgery

Dr Prashant Kumar Singh, housestaff, dept of neurosurgery

Dr Mozammil Aqdas, intern

Dr. Sridam Porel, intern

Dr Entekhab Ansari, Intern

They tried to throttle me. They forcibly held me and hit me with brute force as seen in footage circulated by many reputed media houses.

Dr. Mozammil aqdas grabbed me from behind and tried to throttle me while others beat me up and Dr. Entekhab Ansari hit me in the face.

Dr. Sridam porel continuously punched me in the chest with help of Dr. Prashant Kumar singh. And Dr. Md Sahadat Islam continuously provoked the other 3 above mentioned people, and he also attacked me.

Also Taksir Alam, a first year student pulled me with such force that my hands got bloodied.

Their criminal acts have left me physically wounded and mentally devastated.

This kind of malicious act is cognizable offence according to BNSS Section 2(g) and BNS(the Bharatiya Nyaya Sanhita Under Section 3(8) 351(1), 352, 111, 354, 101, 102, 120, 121, 109.

I request you to kindly look into the matter and take the strictest action possible against these students.

P.S - More of the video evidences can be found from the CCTV footage in the principal's office, I have Video proof with me. Incident happened on 12th march, 2025 at around 5pm to 7pm.
