Sir,

I, Sri Tapas Bishui, Divisional Engineer (E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Partha Ghosh, S/o- Lt. Nipen Ghosh, Ground Floor, Prakriti Apartment, Sanghati More, Ward No.-38, Siliguri, Dist-Jalpaiguri for having committed offence as stated here under.

On 17.03.2025 at about 11.55 a.m. acting on a source information I, along with 1) Sri Bijay Lakra, D.E., S&LP Wing, Darjeeling Region, WBSEDCL, 2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Partha Ghosh and inspected service installation, metering installation of Consumer ID 402098579 in the name of Partha Ghosh. During inspection it was found that Partha Ghosh is using electricity unauthorisedly & illegally by reconnecting the disconnected service line of the metering installation that was disconnected previously on 30.01.2022 due to non-payment of outstanding energy bill. Total LPSC dues Rs.1263.00 (Rupees one thousand two hundred sixty-three only) till the date of 17.03.2025.

As unauthorised reconnection of the disconnected service line and metering installation was detected, the energy meter, make Bentec Bhartiya Engineers Pvt Ltd., serial no. - BB0437391 installed against Con Id. 402098579, seized by preparing a formal seizure list duly signed by witnesses.

As Partha Ghosh have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
