With due respect, I am producing herewith one accused namely Rajkumar Dey (32 yrs) S/O Mantu Dey of Taherpur, PO+PS- Taherpur, Dist. Nadia at present residing at Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following seized articles viz :- (i) one merrun colour Scooty displaying number plate WB/74/AT/0323 - Marked as Exhibit "A" (ii) One paper made cartoon containing 12 bottles of TUBORG" premium Beer each bottle containing 650 ml i.e. total (12 x 650 ml) = 7.8 marked as Exhibit "B", out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1" and (iii) one black colour carry bag containing 06 bottles of HIMALAYAN Gold 60 up India Made liquor each bottle containing 600 ml i,e, total (06 x 600ml) = 3.6 ltrs - marked as Exhibit "C" out of which one bottle of the same taken as sample for examination and marked as Exhibit "C1". I SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodged this written complaint against accused person namely Rajkumar Dey (32 yrs) S/O Mantu Dey of Taherpur, PO+PS- Taherpur, Dist. Nadia at present residing at Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 17.03.25 at 22.25 hrs I received source information that one person namely Rajkumar Dey of Coolipara, PS- Pradhan Nagar, Dist. Darjeeling is possessing a huge quantity of illicit liquor in his scooty having registration number WB/74/AT/0323 and selling the same to his design customers at Siliguri Junction near Jay Matadi Bus service counter under PS- Pradhan Nagar, Dist. Darjeeling. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No. 1055 dated 17.03.25 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallick, ASI Prabal Sarkar, ASI Biplab Kumar Das, C/1411 Ashok Roy C/1413 Sujit Sarkar all of Pradhan Nagar PS left for Ganga Hotel, Pradhan Nagar under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at Siliguri Junction near Jay Matadi Bus Service Counter I contacted with my source and being identified by the source, from a considerable distance I noticed that one person was standing at near Jay Matadi Bus Service Counter with one scooty having registration number WB/74/AT/0323 and he was selling liquor in public place to his design customer from his scooty. Accordingly, we cordoned the place and managed to detain him. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation he disclosed his identity as noted above and on search the scooty in his possession recovered the above noted articles which were kept in the scooty. On demand he failed to produce any valid documents in respect of the above noted liquor recovered from his possession. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal ligior from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 23.15 hrs to 23.35 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Rajkumar Dey (32 yrs) S/O mantu Dey of Taherpur, PO+PS- Taherpur, Dist. Nadia at present residing at Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.
