I, Muskan Guwung D/o Mukesh Guwung resident of Panchanadi
Agam Singh giri nagar, Dagapur Dist. Dargjeeling West Bengal-734003
wish to lodge a formal complaint regarding the theft of
my motorcycle that took place on 11th March 2025, at approximately
8:30 PM from the outdoor premises of Sukna Tea Estate
Primary School, near Gulma Tea Estate, Dagapur.

On 11th March 2025 at around 8:30 PM my motorcycle a KTM Duke
390 bearing registration number NB74BU 3778 and chassis no:-
