With due respect and humble submission, I ASI Chandan Chakraborty of Matigara P.S do hereby lodge this written complaint to the effect that today on 19/03/2025 I was deputed to perform K-33 Van duty along with force, since 14:00 hrs vide Matigara P.S. C.C. No. 26/2025, Dated -19/03/2025 and Matigara P.S. GDE No. 1069/25, Dated - 19/03/2025 in course of said van duty I received source information that 01 (One) vehicle Dumper White colour bearing Regn. No. WB 73 D 7559 is standing at Khaprail Road in front of Army Quarter under Matigara PS area loaded with river stone chips which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed at Khaprail Road in front of Army Quarter under P.S.- Matigara and found the above noted vehicle loaded with river stone chips standing in front of Army Quarter at Khaprail Road. On seeing the Police team the driver of the vehicle managed to flee away from the spot to leaving the vehicle abandoned. It is crystal clear that the driver/owner of the vehicle Dumper White colour bearing Regn. No. WB 73 D 7559 procured the loaded river stone chips from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain. I tried hard to traced out the driver / Owner of the vehicle but in vain. Nobody came forward to claim the vehicle.

Finding no other alternatives, I seized the vehicle Dumper White colour bearing Regn. No. WB 73 D 7559 loaded with river stone chips under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S. The seizure was made in between 21:45 hrs to 21:49 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver/owner of the seized vehicle Dumper White colour bearing Regn. No. WB 73 D 7559 and arrange for its investigation.
